5. Periodic readjustment of relief cases to correspond with relief needs. 6. Make the program, as much as possible, on the basis of practices among private contractors.

7. Make available to the press and public full information on all relief projects, to quash rumors and operations. 8. Hurley, a Bridgeport engineer, said he would endeavor to have the program carried out as efficiently as possible.
