

ROOSEVELT FAMILY UNWITTINGLY FANS ALIEN RED SPIRIT

Brooklyn Professor Says President Lauded Youth Congress in 1936 And Wife Has Inspired Group.

Washington, Aug. 23.—(AP)—A witness told the House-American Committee today the "Stalinist-supported chairman" of the "alien directed" American Youth Congress had received a letter from President Roosevelt in 1936 lauding the congress for aiding democracy.

Professor Edward L. Felton of the philosophy department of Brooklyn College added that "another of the President's family has gone on the way unwittingly to inspire the alien spirit that undoubtedly controls this congress. Felton did not name the member of the family immediately, but later said it was Mrs. Franklin D. Roosevelt.

The congress "the President also sent a letter of regard to the American Youth Congress at its last December meeting at Poughkeepsie."

Program Deliberate
Felton, bespectacled middle-aged professor who came to Brooklyn College from St. Mary's College in California eight years ago, said there was a deliberate program to "pull the wool over the eyes of the authorities and people."

The witness also contended that the World Youth Congress at Yass, Bulgaria, was radical-dominated and a "danger" to democracy because it serves to spread the "alien" spirit of Communism.

Previous witnesses before the committee had mentioned that Mrs. Franklin D. Roosevelt had addressed this group last week and in so doing had been "exploited" by Communists.

Own College Method
Felton also told the committee that Brooklyn College "might quite fairly be labeled a hotbed of propaganda and Communist activity."

Professor Felton professed his mention of the President's activity with a suggestion that Communists might be misled if authorities realized its danger and agreed on means to check it.

"But a spirit of what is called 'liberalism' has taken hold among the appreciable number of so-called 'high places' and in consequence Communism has a pretense of being unopposed in certain circles and institutions," he asserted.

"In lieu of being unopposed, it is actually being protected."

NOTE ON FARMS SENT TO MEXICO

Hull's Reply To Rejection Of United States Proposal To Be Made Public On Friday

Washington, Aug. 23.—(AP)—Another State Department note went to Mexico City today about Mexico's expropriation of an estimated 1,000,000 acres of American-owned farm land.

Secretary Hull sent it by messenger to Mexican Ambassador Francisco Najera last night. The two men earlier had discussed the situation in an hour's conference.

Transmitted By Mail
Ambassador Najera transmitted the note to his government by mail so that there would be no mistakes in transmission. The text will be released here and in Mexico City Friday morning.

The note replies to Mexico's note of August 3 rejecting a United States proposal for inter-American arbitration of the dispute. Hull had requested "prompt and just compensation" for the properties seized.

Mexico rejected the arbitration suggested on the grounds that the dispute was not irreconcilable and could be settled directly between the two parties.

Some persons close to the State Department expressed belief the second United States note contained to insist on inter-American arbitration under the treaty of 1923, but that without confirmation.

Approves Names Chosen For Eight New Warships

Hyde Park, N. Y., Aug. 23.—(AP)—President Roosevelt approved today the names for eight new warships.

The summer White House announced that the next four battleships to be built will be christened the Indiana, Massachusetts, Alabama and South Dakota. Four new light cruisers will be called the Atlanta, San Juan, Juneau and San Diego.

Recent congressional authorization provided for the ships. Names for the battleships were provided by the Navy department from the list of retired vessels, the names of those longest out of service being chosen.

The last Indiana and Massachusetts went off the navy list in 1920, and the last Alabama in 1921. The last South Dakota never was completed, but the portion of the vessel on which work had been discontinued in a recent statement, as approved for christening by James P. Harbo, chief clerk.

BLODGETT RAPS RULE OF CROSS FOR LAST TIME

Reaffirms Charges Of Waste And Nepotism In Tax Department, Attacks Cutting Staff Of Education Board.

Hartford, Aug. 23.—(AP)—William H. Blodgett, state's attorney of Litchfield County, had today made what he described as his final "criticism of state affairs under the management" of Governor Wilbur L. Cross.

But, before concluding his verbal battle with the Democratic state administration, Blodgett, a Republican and former state tax commissioner, reaffirmed charges of waste and "exalted nepotism" in the state tax department, attacked the cutting down of the staff of the Connecticut Board of Education and that the present finance setup of the state will probably not "see very well with the next General Assembly."

Firing Last Broadside
Blodgett, in a statement issued to the press here last night, said he was firing his last broadside at the present administration. He asserted:

"The chairman of the Republican State Central committee has been authorized to take up this and other public work."

Blodgett also cited the need for the Republican Party "to assume its responsibility and point out the shortcomings of the party in power."

Resuming his fight with State Tax Commissioner William H. Hackett, Blodgett said he cannot understand Hackett's denial of nepotism in the department.

Hackett's nephew is employed in the department, Blodgett said.

Disqualified Himself
Blodgett said Hackett was incorrect when he said that he was not a member of the party. He said Hackett had given a promotional examination by a member of the party, and that he himself was disqualified from the examination, having been a member of the party.

BODIES PROVE FOUR CONVICTS WERE SCALDED

Philadelphia, Aug. 23.—(AP)—Autopsies today revealed that four "hunger-striking" inmates of the Philadelphia county prison.

Philadelphia, Aug. 23.—(AP)—Coroner Charles H. Hersch said today that the bodies of four hunger-striking prisoners found in cells at the Philadelphia county prison showed definitely that the men were scalded to death.

"There is no question but that these men got their death by scalding," he said. "Their hands were shriveled, indicating they had been in hot water or steam."

Warden William B. Mills said he could not contradict the coroner but "can't see how that could have taken place."

"We certainly use no steam or hot water on the men," he said, "and there are no steam or hot water pipes in the building in which they were confined."

Meanwhile, at least four investigations got under way and autopsies were scheduled for later today.

State Secretary of Welfare Charles E. Engeman sent two special investigators to the institution at Honesburg with orders to "get to the bottom of the hunger strike, which resulted in the four being placed in punishment cells where their bodies were found yesterday."

They were among more than 600 prisoners who had refused to eat in protest against a "monotonous" diet of hamburger and spaghetti. Discovery of the bodies came after a night during which, Warden Mills said, some 20 convicts in the punishment cells had been fighting furiously with their fists.

Dr. Morton Crane, the coroner's physician, declared the men had died of typical death by gas.

"I am of the opinion that scalding was the typical death by gas," he said. "All four exhibited the symptoms of nasal congestion that is typical of death by gas."

There were also bruises and abrasions on the skin which were still showed clots of blood. That would indicate clearly to me that they were beaten before being scalded to death by gas.

Judge Harry S. McDevitt of the common pleas court who had sought to end in settling the hunger strike, said he was told the prisoners broke steam pipes in their cells to use as weapons.

WEINBERG SAYS HINES PLEDGED PROTECTION FOR POLICY BANKERS

Million Men Will Protect Hankow Area

Civilians Also Mobilized To Carry On Behind-Lines Duties; Women Trained As Nurses, Military Aids.

Shanghai, Aug. 23.—(AP)—A million soldiers and 200,000 civilians were reported mobilized today to protect the Hankow area should the Japanese break the deadlock that has kept them 110 miles from the provincial Chinese capital for nearly a month.

The Chinese civilians were being trained in many behind-the-line duties and military aids. Included were 60,000 ricksha pullers who would become a troop transport corps.

Chinese newspapers which reported these details also said women were being given important roles in the war effort. Women's corps were being trained to care for the wounded. Many college graduates, members of the Chinese Red Cross and other groups were being trained to be among the corps members.

Manpower Struggle Continues
The Chinese-Japanese struggle for mastery in Poyang, about 130 air miles southeast of Hankow, continued today with undiminished vigor.

The Chinese maintained the invaders had landed on the west shore of Poyang but were clinging to a narrow strip of land about 30 days' march from the city.

HUNGARY GRANTED ARMS EQUALITY

Little Entente Nations Reach Decision Calling For Revision Of Trianon Treaty.

Bled, Yugoslavia, Aug. 23.—(AP)—The Little Entente swept away the military clauses of another World War treaty today and gave Hungary the right to return to the interest of peace.

The three nations—Czechoslovakia, Rumania and Yugoslavia—agreed to abrogate arms restrictions in the Trianon treaty and grant military equality to Hungary.

The action followed a similar move by the Balkan states, which include Rumania and Yugoslavia, on July 20, wiping out military clauses of the treaty of Neuilly.

"Air Dreadnaught" Ready For Tests By Navy Fliers

San Diego, Calif., Aug. 23.—(AP)—Arthur L. Crinkley expects to pilot a giant flying boat, estimated capable of a 3,000-mile flight to patrol or bomb, was ready for tests today by the United States Navy.

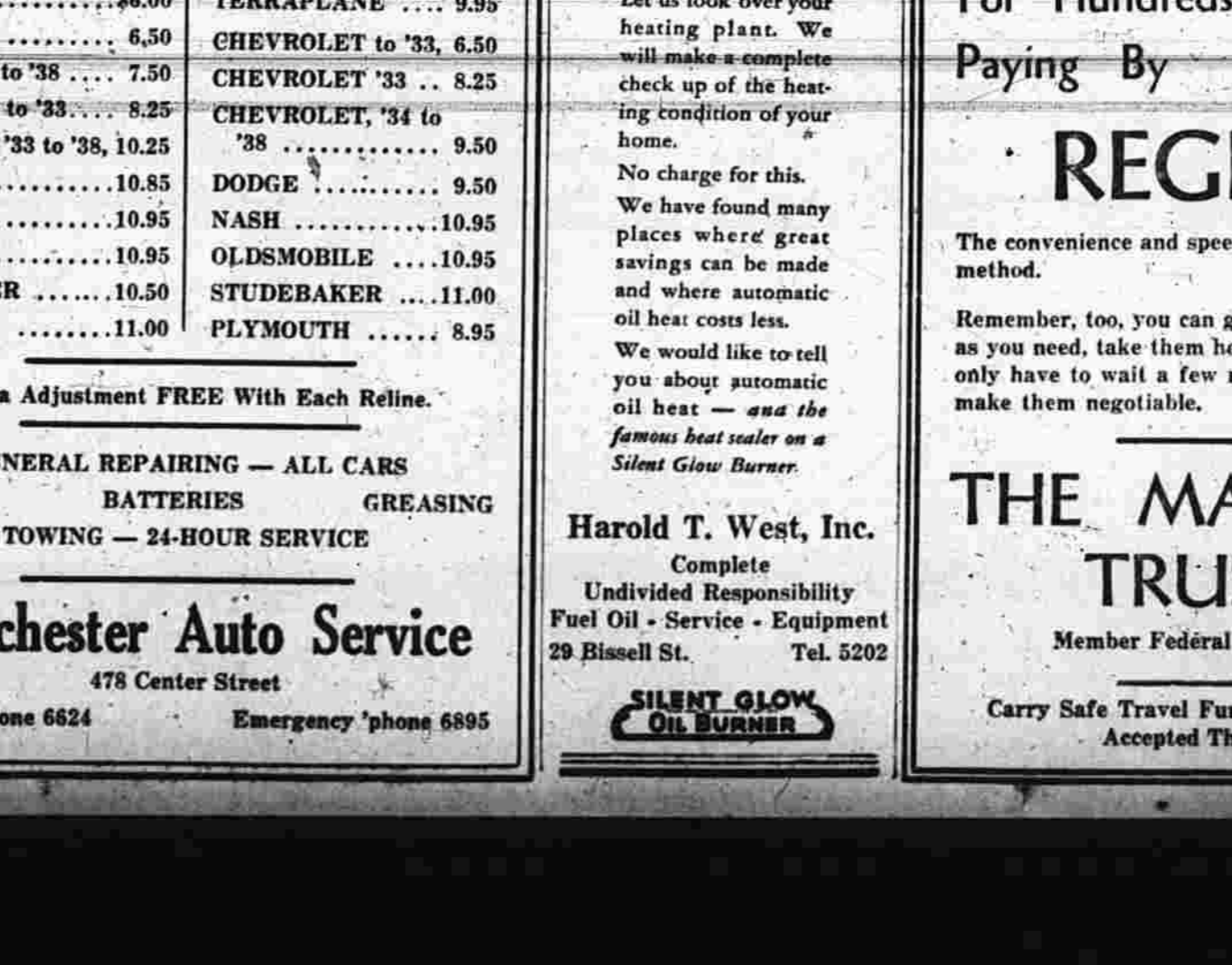
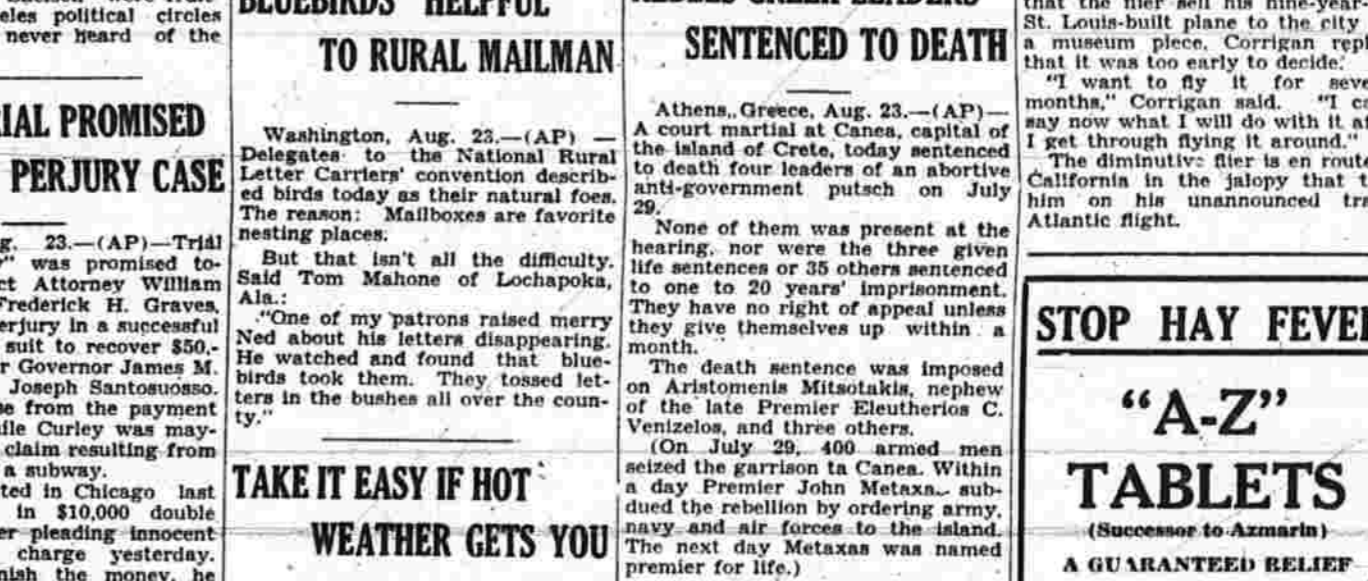
