27 VENIREMEN

ARE EXCUSED
IN 6TH PANEL

Opposing Counsel At Water-
bury Resumes Quest For
Two Alternate Jurors Be-
fore Taking Of Testimony

Waterbury, Jan. 11 — (AP) — Twenty-seven of 102 veniremen summoned for the Waterbury million-dollar fraud trial were excused for various reasons at the outset of today's court session and opposing attorneys then resumed their quest for two alternate jurors who must be chosen before the taking of testimony begins.

The six veniremen panel reporting today brought the total summoned as prospective jurors since Nov. 20 to 177. In addition to the 75 veniremen left today after the 27 had presented excuses, there were 15 remaining from the fifth bench.

The 22 defendants, including Mayor and former Lieut. Gov. Frank Hayes, are charged with conspiring to defraud Waterbury over \$1,000,000.

Four of the 27 veniremen excused today were women: Mrs. Rena Bennett of Ansonia, Mrs. R. May of Derby, Belle L. Slater of New Haven.

Eleven Veniremen Challenged
In less than an hour, the fifth panel was nearly exhausted, 11 veniremen being challenged in rapid succession.

Among them was William P. O'Brien, a well-known musician, who testified he was now employed on a WPA inventory project in Waterbury.

The inventory, the venireman testified, covered property owned by the city.

"Did you find it all?" Special Prosecutor Hugh H. Johnson asked before O'Brien could reply. Judge Ingalls told him he did not need answer the question.

On Alcorn's motion, O'Brien was excused. He had known Mayor Hayes for many years and had a speaking acquaintance with others of the accused.

Soon after the defense challenged John F. Conson of New Haven, 68-year-old retired freight claim agent of the New Haven Railroad, the venireman said his impression of the case was that "there was something rotten in Denmark."

TRUCK DRIVERS

ACCEPT TERMS
TO END STRIKE

Compromise Offer Agreed
Upon After Governor Sal-
tonstall Appears Before
Men To Make Appeal.

Boston, Jan. 11 — (AP) — A seven-day strike of 6,000 greater Boston truck drivers and helpers, which had paralyzed many of the city's terminals, ended today when the strikers accepted a compromise wage proposal.

The proposals were accepted on an overwhelming vote after the strikers had rejected a similar offer made by the employers.

Only about 50 scattered "no's" were recorded when the strikers answered the question of their union president, John M. Sullivan, "Shall we accept the proposition?"

Move To Sign Contract
The State Board of Conciliation and Arbitration at once moved for the signing of a contract which would move millions of dollars worth of strike-bound perishable commodities tied up to Boston freight terminals and on highways.

"We're going back to work. We're going back to work," the strikers chanted as they rushed from the hall where the vote had been taken and headed toward the wharves and terminals, where in many instances trucks were waiting to be driven away with long-trail goods.

"That's all," was Governor Saltonstall's laconic comment upon receiving the news of the ending of the walkout that had been marked by one death and by sporadic violence.

The agreement which ended the strike was announced today.
