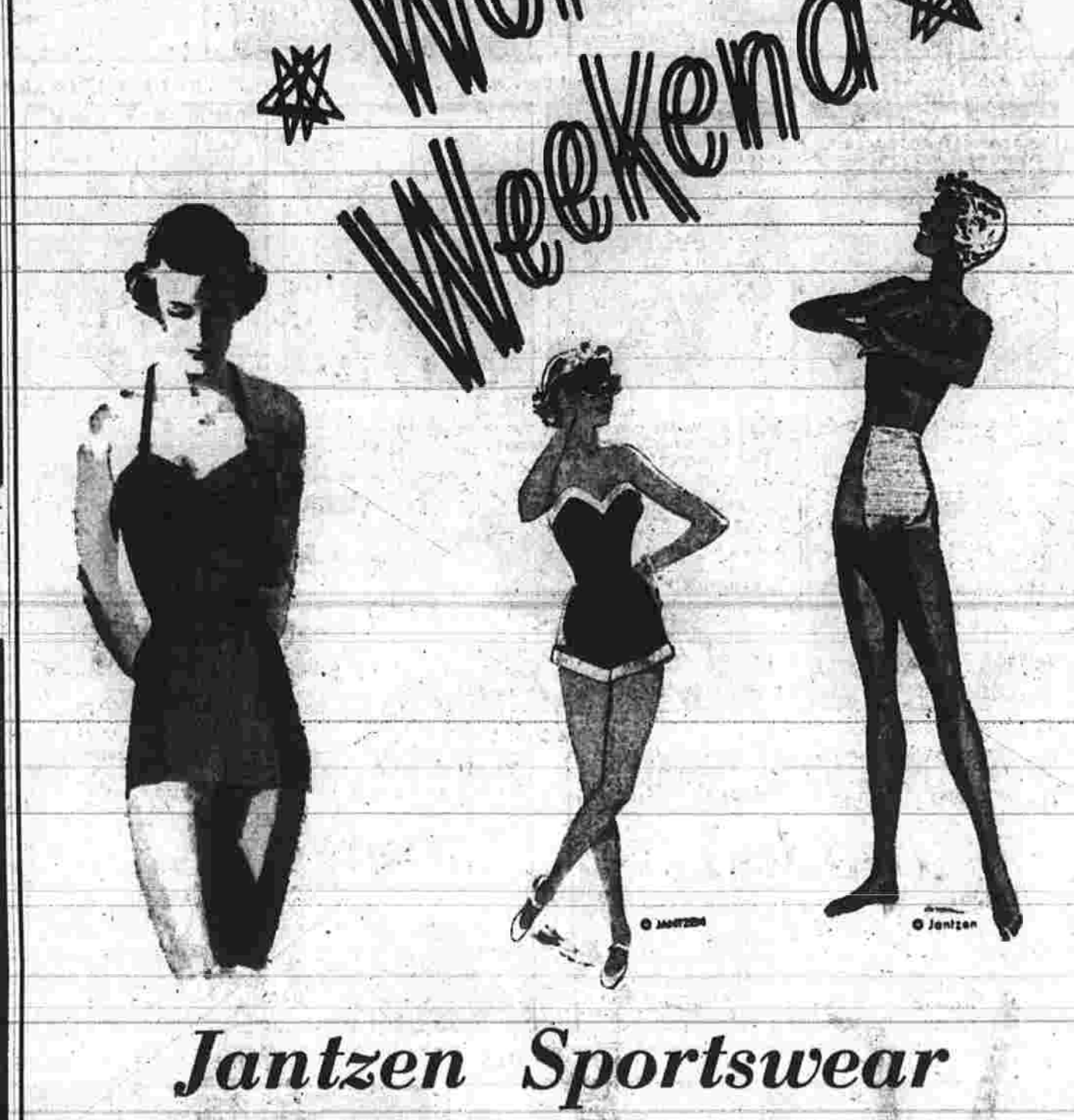

Seoul, Korea, May 24—(AP)—The Allies struck the greatest air blow of the Korean war at the Red's Thursday and Friday, against a sobering picture of increasing plane losses. The weekly plane loss count gave the Communists 12 kills and U. S. airman four.

The Fifth Air Force tally showed the week ended Friday was one of the worst—if not the worst—air weeks for the Allies since the war started 23 months ago.

Two Navy Losses The figures don't take into account naval plane losses. Accurate figures indicated there were at least two—bringing the total lost to at least 12. Airmen and crew members appeared to point to growing Communist skill and power in the air and on the ground.

Every U. S. combat unit of the Fifth Air Force and scattered Royal Australian, South African, Korean and American Marine planes—explosives and piloted guns—were reported to be in the air over the Korean peninsula.
