for the protection of the innocent then to distort and subvert them in order to block the escape from punishment of even an apparently guilty person.

"Such has even been the policy of this state.

According to the confessions introduced to the Hartford County Superior Court when Doucette was tried and convicted in 1958, he had been living with Mrs. Regina Hunt Lee for some eight months when the child was born.

The documents said Doucette suspected the baby had been fathered by some other man. The prosecution offered the evidence that Doucette's motive for wanting the child dead.

On the night of the child's death, according to the confessions, an acquaintance, Edward J. Rogers, was present as Doucette held the child in the gas-filled oven.

A medical examiner's report filed at the time of the death gave no indication that the death was caused by foul play. This was changed to specify that the death was a homicide after Doucette had made his confessions. The amended death certificate was admitted as evidence in the murder trial.

This was another error, the higher court said, because the medical examiner had ordered the change in the death certificate on the basis of what the police had told him they had learned from Doucette instead of what he had ascertained for himself in the examination of the body two years earlier.

"I'm studying the decision, but it seems doubtful we can supply any further evidence of the corpus delicti," said State's Atty. John D. LaBelle today. "I'll probably note the prosecutor said he would decide what to do within the next 10 days.

Bolton Teachers Seek Maximum \$7,250, Minimum, \$4,200

Bolton teachers presented a 12-page salary proposal to the Board of Education last night, asking a \$4,900 minimum and a \$7,250 maximum.

The proposal compares to the present salary contract with \$4,000 minimum and \$4,500 maximum. Annual increments under the new proposal would be \$300 per year for the first six years and \$250 thereafter. Total cost of the salary schedule would increase the school budget \$14,000 during the first year.

On the present staff nine teachers and two on the next year would be one each on the ninth and tenth, three on the third and fifth, and two on the second and sixth.

The Board will study the proposal and meet with the teachers at a later date for further discussion. In planning for classroom facilities for the 1960-61 year the Board voted 5 to 1 in favor of 19 classrooms, the same number at present in the school system. Mrs. Agnes Keywood, in charge of the school, said that the school is in need of three Grade 3 classrooms, three Grade 2, two Grade 1, two Grade 6, one probable combination Grade 4 and 5, two Grade 5, two Grade 6, two Grade 7, and two Grade 8 classrooms.

The tentative enrollment for 1960-61 as of September 1, 1959 was 549 pupils. Breaking this into grade levels it places 62 children in Grade 1, 81 in Grade 2, 65 in Grade 3, 79 in Grade 4, 79 in Grade 5, 65 in Grade 6, 65 in Grade 7, and 62 in Grade 8.

The Board recommends that as of Sept. 1, 1960 each child prior to entering the local school should be immunized against polio. Members felt that at the time they did not want to make it a compulsory policy but a request because of the controversial cases in other towns on the size and until final results of the new oral immunization techniques are formulated. Supt. George Graf pointed out that in Bolton very few students have had their shots and most of these were in the process of having the shots.

You Should Know... Alfred Fredette

Two years and 5,000 slides ago, Alfred Fredette, teacher of one of the nationally ranked classes at the Keene Annex, decided to take a camera with him on a visit to Neassu.

By the middle of this month he may have the firm of many educational film strips about nature ready for sale.

Using an Ektachrome camera and a 400 millimeter lens, the same type lens Walt Disney used to film the squirrel story, "Pete," Fredette has managed to capture shots of animals in their native habitat.

These pictures, along with hundreds of shots of flowers and plants will be used in the series "Our Natural Environment." The series will be geared to the needs of the elementary, junior and senior high school levels, and will be distributed by the "N.E." film service.

Standart Art

The 30-year-old teacher was helped in the composition of his photographic work by a long and thorough background of artwork.

Fredette took art lessons while he attended Windham High School, from which he was graduated in 1948, and then he went on to work during the night in the material control department at the American Brown Co. in Wilton, and took art lessons during the day.

Among the professional artists with whom he has studied are James Timmons, Langdon Allen, Walter Van Arsdale, Leysa Holden and Guy Wiggins.

Fredette found that whatever he drew or painted—sometimes even scribbled.

In 1952, he decided to return to school and obtain his bachelor's degree.

He went to Willimantic State Teachers College, from which he was graduated in 1956. Immediately, he was invited by East Hartford to teach a class of mentally retarded children.

A year later, having found that he liked the work, he accepted a similar post in Manchester.

The longer I do it, the better I like it," he says of his work. He has 15 children in his class at the Keene Annex.

At the same time that he's been teaching, he has found that his art hobby has contributed both to his teaching and to other pursuits.

Attended Seminars

For one thing, his interest in teaching art to mentally retarded children was naturally keen, and so he joined the New York State Committee on Art Education for the Mentally Retarded. He attended seminars conducted by such artists as Victor D'Amico, Victor Lowendoff, Ben Shahn, and others.

In April, his own article on teaching art to mentally handicapped children will appear in the School Arts Magazine. With it will be illustrations consisting of work done by the children in Fredette's class at the Annex.

Does Illustrations

In 1956, he illustrated some pamphlets for the Connecticut State Department of Mental Health. This led him to illustrating an article for the American Medical Journal. He drew six or eight pictures showing a radical new way of removing fat tissue.

His work on the pamphlets and for the Medical Journal in turn led him to be chosen as the illustrator for a children's science book, written by Dr. Robert Wolcott of Willimantic State College.

Fredette started drawing illustrations for the book in May 1958 and had finished them—several hundred in all by December of the same year.
