Gemini 9 Flight Set On May 17

CAPE KENNEDY, Fla. (AP) — Gemini 9 astronauts Thomas P. Stafford and Eugene A. Cernan will be launched into space on May 17, the National Aeronautics and Space Administration announced today.

News media have carried this date for several weeks. But NASA makes a practice of not making an official date announcement until about 30 days in advance.

During the three-day flight the astronauts are to link up with an Agena satellite and Cernan is to take a lengthy space walk of about 2½ hours.

The flight will be similar in many respects to that which had been planned for Gemini 8, which had to make an emergency landing last month when a jet thruster stuck open because of a short circuit and sent the spacecraft spinning wildly in space.

The trouble occurred after the Gemini 8 pilots, civilian Neil A. Armstrong and Air Force Lt. Col. David R. Scott, completed the world's first hookup with another satellite, an Agena.

Stafford, an Air Force lieutenant colonel, and Cernan, a Navy lieutenant commander, are to catch the Agena in the third or



Secretary of State Rusk Adjusts Papers on the Witness Stand

Nonaligned Viet Regime No Problem, Rusk Says

WASHINGTON (AP) — Secretary of State Dean Rusk told senators today that if elections in South Viet Nam bring to power a nonaligned government "it would create no problems for us."

The problem, Rusk told the Senate Foreign Relations Committee, is that the Communist regime in Hanoi isn't interested in nonalignment but wants to take over South Viet Nam.

"We support the idea of elections in South Viet Nam," he said, but "the other side is not willing to depend on elections."

Rusk expressed confidence that if elections are held as planned this August, the people of South Viet Nam will not "be the first people to elect a Communist regime."

Rusk, the first cabinet officer to be questioned in public by senators since the drive for elections broke out in Viet Nam during Congress' Easter recess, said he understood the election

of a constitution-making assembly will be held in August.

"It has been apparent throughout these recent discussions that there is general agreement among all of the participants that they reject the Viet Cong and the efforts of Hanoi to impose a political solution upon the south by force," said Rusk.

"It is important of course that these political processes proceed on the basis of solidarity on the eventual aims with respect to South Viet Nam even though, as we ourselves learn, the construction of a basic constitutional arrangement is a complicated and difficult matter."

Rusk testified in the relatively small Senate Foreign Relations Committee hearing room which was jammed with cameras and other equipment and which had a waiting line for the spectators seats.

"I think it is important that these political, economic and social works of peace continue even while the military struggle continues," Rusk said.

That is why, he said, that American and South Viet Nam leaders "reaffirmed our commitment to improve the life of the Vietnamese people in the declaration of Honolulu."

"For we recognize that, while we could win the victory on the battlefield, we could still lose the more important fight for the future well-being and progress of the people."

Rusk's testimony came after Barry Goldwater charged President Johnson is playing politics with the Vietnamese war by trying to keep it at "a low level" to save Democratic seats in next fall's congressional elections.

Committee Chairman J. W. Fulbright, D-Ark., advocated again a shift in foreign aid emphasis to assistance through multination organizations.

"It seems bilateral programs tend to identify us with particular regimes and in a way make us prisoners of smaller countries," Fulbright said. "I can't get over the fact that our Viet Nam intervention started out

High Court Revokes Arizona Loyalty Law

WASHINGTON (AP) — The Supreme Court struck down today an Arizona law requiring a loyalty oath of state employees.

Justice William O. Douglas delivered the 4-3 decision. Justice Byron R. White wrote a dissenting opinion. Justices Tom C. Clark, John M. Harlan and Potter Stewart joined in White's opinion.

The court ruled on an appeal by Barbara Elfrandt, a public school teacher of Tucson who refused to sign the oath.

The law says public employees who refuse to sign must be taken off the payroll, although not discharged. Mrs. Elfrandt has taught for eight years without pay.

She contended the requirement denied her right of free association and free speech. She is a member of the Religious Society of Friends — Quakers — but her attorney emphasized before the Supreme Court that the fact was not being argued in the case.

Vernon Elfrandt, husband of Mrs. Elfrandt, likewise refused to sign and has taught for eight years without pay. The attack on the state law was brought in her name only.

Estimates were made that if she won the case, the Elfrandts would likely collect back pay of about \$60,000. The former Spokane, Wash., couple have received financial aid from friends and supporters of their beliefs.

Douglas for the court majority said the Arizona law "threatens the cherished freedom of association protected by the First Amendment."

GOP's 'Consensus Choice' May Be Announced Today

NEW HAVEN (AP) — A group of Connecticut newspaper editors and political writers predicted in a weekend poll that State Sen. Peter Mariani of Groton will be the Republican party's "consensus choice" for the gubernatorial nomination this year. They probably will get a chance to find out this afternoon if they were right.

State GOP Chairman A. Seattle Pinney has scheduled a news conference for 4 p.m., and while he did not say what the topic would be, it was generally assumed to be for the purpose of designating the consensus

candidate. There were some strong indications among party leaders close to Pinney that the name forthcoming would not be Mariani's but that of E. Clayton Genaras, the West Hartford business executive who has been making a late-start run for the nomination.

Many party leaders felt that having several contenders scrapping for the nomination at the Republican State Convention four years ago weakened rather than strengthened the party's chances of victory at the polls.

By singling out one man now and proclaiming him the contender most acceptable to the leadership, they hope by convention time to have rallied support from all segments of the

party for this prospective nominee. In the poll, Mariani received 11 votes to five for Genaras. In addition, the newsmen also chose Mariani by a big margin as the Republican who SHOULD be the consensus candidate.

Mariani got 11 votes. Genaras, former State Sen. Wallace Barnes of Bristol and former GOP State Chairman Edwin H. May Jr. of Wetherfield got one each of the votes on this question.

All told, 17 newsmen from 14 AP member newspapers throughout the state replied to the poll.

One declined to predict who the choice might be because he said it was impossible to know.

Two said they did not know who should be, with one of these replying: "If the Republicans can't find out who the best candidate is, how the hell can I?"

A third said he did not know who should be the candidate, but that he did not think the Republicans "should go again with the president of a Hartford insurance company."

Genaras is the board chairman of the Security Insurance Group of Hartford and of the Connecticut Co., a bus service.

Four years ago the unsuccessful GOP nominee was John Alsop of Avon, president of the Mutual Insurance Co. of Hartford.

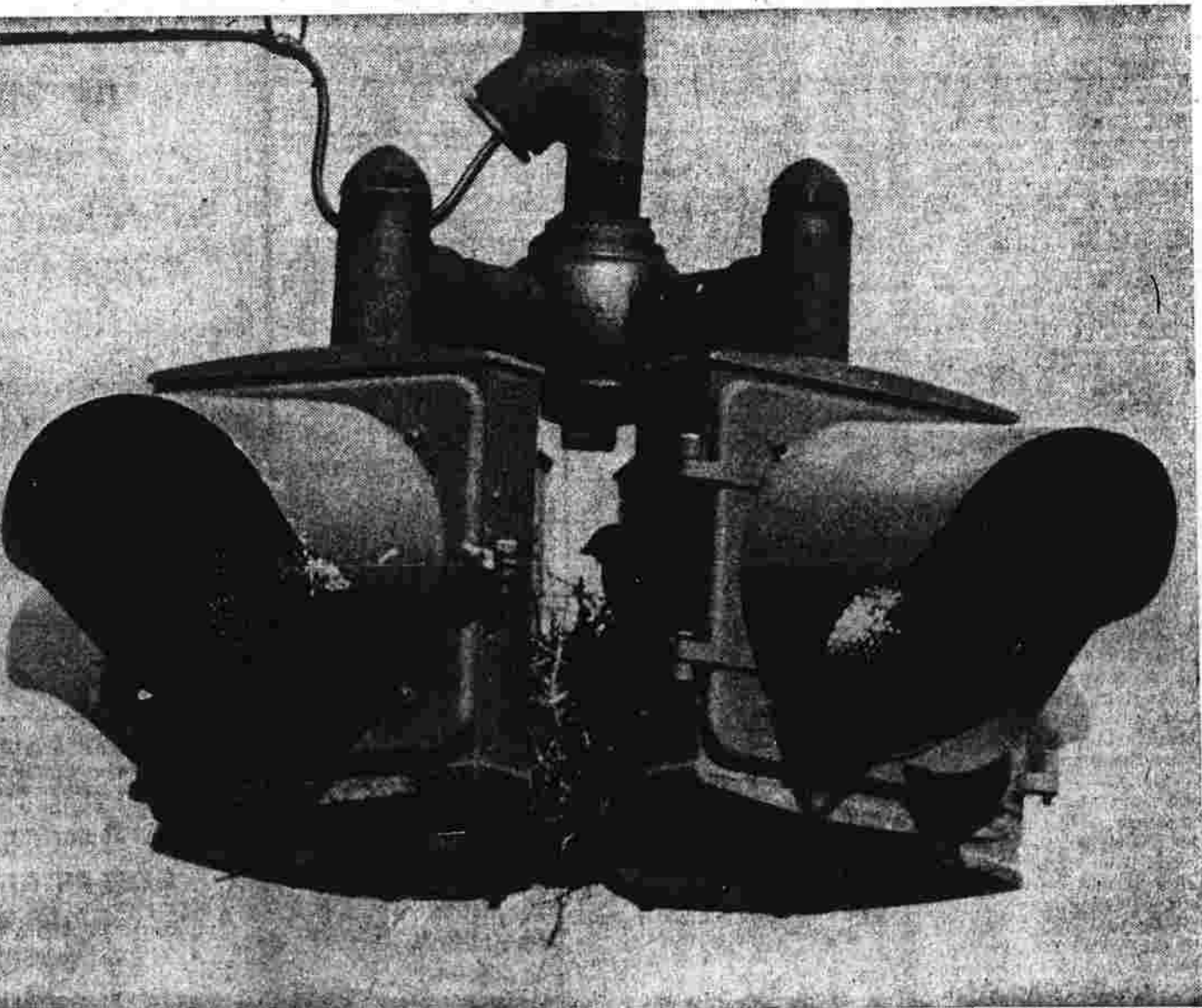

Merged Papers Or None, Say N.Y. Publishers

NEW YORK (AP) — Matt Meyer, president of the corporation formed by three merging New York City newspapers, says "we will either publish our two daily papers on April 25, or we will publish no papers at all."

The corporation, the World Journal Tribune Inc., is to publish a morning paper, an afternoon paper and a Sunday paper.

Meyer had this statement Sunday for the 10 newspaper unions, none of which has reached an agreement with the new corporation.

"The April 25th date for starting our new newspapers is firm, and unless the unions recognize that this calls for some production work early this week, a situation tantamount to a strike is inevitable."

The Herald Tribune a morning paper, is scheduled to be published next Monday, April 25, as the first edition of the new corporation.

The Greats Sing Farewell To Old Met Opera House

NEW YORK (AP)—Some of the world's greatest singers sang at 1:25 a.m., with the audience chanting and chorus on stage holding hands, and everybody singing "Auld Lang Syne."

The evening was not as tearful as had been expected. The audience radiated excitement as famous singers followed famous singers in arias, duets and trios, and a prolonged banquet with every course delicious. The Met, clichéd and fishbaldie popped. The performance was not broadcast or televised and music with tape recorders and portable television cameras pointed with guests in the crowded corridors at the two intermissions, along with autograph seekers, looking for celebrities. People thronged outside, a few carrying "Save the Met" placards.

The Golden Horsehoe will hear opera no more; in three weeks it will be torn down for an office building. The Met opens its season next September at a new \$45-million building at Lincoln Center for the Performing Arts.

The singers at the gala made sure the farewell night was a blaze of vocal glory.

Leontyne Price, singing from "Il Trovatore," has seldom if ever sounded richer.

Zinka Milanov, who has sung 25 performances in 25 seasons, and was making her own farewell appearance, sounded as fit as could be a long way from retirement. She sang the final "Sueño" from "Andrea Chénier" with Richard Tucker. They were called back for six bows—more than anybody else.

The audience, which had paid to \$200 a ticket, a total of \$250,000, was even more talkative at intermissions and more elaborately garbed and glittering. They swelled than at a Metropolitan night. Cornelius Van derbell Whitney, whose two great-grandfathers had helped found the Met, was there with his wife. She was wearing a diamond and ruby wedding ring and had belonged to the Empress Elizabeth of Austria.

Conductor Leopold Stokowski, a spotlight shining on his white hair, made an impassioned plea to save the old Met, just after he had conducted the opening selection of the evening, the entrance of the guests to the Met chorus — from "Tannhäuser."

Turning to face the audience, the 66-year-old Stokowski said, "It is a great pleasure to bring music to an audience of this magnitude and to be able to do so in such a beautiful house. I ask you very much to save this magnificent building, which has witnessed the greatest moments of the world."

Mary Whitehouse, leader of the 30,000-member committee, took umbrage at the performance of a pop song called "I Love the Queen." In a letter to Lord Normanbrook, chairman of the board of governors of the state-supported BBC, she said the song expressed "sentimental affection, in the middle of a program which was written with acerbic and satirical intent."

Voiceprint Trial Is Deadlocked

WHITE PLAINS, N.Y. (AP)—A mistrial has been declared in part of a trial in which voice prints were introduced as prosecution evidence in the slaying of a woman.

Judge Robert Dempsey made the ruling after a Westchester County Court jury reported itself "hopelessly deadlocked" Saturday in the trial of George M. Strachle, a suspended New Rochelle policeman charged with slaying the jury did convict another man also charged with slaying.

The voice print, which charts the human voice in magnetic pictures called spectrographs, may some day rival the fingerprint as a means of identification, researchers say.

Strachle was accused of lying to a grand jury in denying that he had wanted a gun that was an impending police raid.

Voice prints of six conversations, based on an alleged telephone call Strachle made to Peter Rispolo, 66, of New Rochelle, were submitted.

In the same trial, Rispolo was convicted of perjury for his testimony before the same grand jury. He could be sent to jail for five years and fined \$5,000.

Radioactive Soil Burial Finished

AIKEN, S.C. (AP)—The burial of 1,700 tons of mildly radioactive Spanish soil, packed in steel drums, has been completed under 19 feet of South Carolina soil at a nuclear burial grounds near Aiken.

The debris was collected near Palomares Beach on the coast of Spain after two U.S. Air Force planes collided Jan. 31 and two nuclear bombs burst around and open, spreading plutonium over tomato fields. Another bomb was easily recovered and a fourth recently was pulled from the Mediterranean.

Officials ordered the soil packed in steel drums to relieve fears of Spanish fishermen and farmers. The soil was shipped to Charleston where it was transferred to 36 railway cars for the overland trip to the burial grounds.

Burial of the contaminated soil and tomato waste was completed last Thursday at the site in such a beautiful house. I ask you very much to save this magnificent building, which has witnessed the greatest moments of the world.

Following close on the attack Sunday on missile sites near Hanoi, two Navy planes in a low level, radar-controlled attack dropped about 15 tons of bombs on the Tung Bi power plant 14 miles northeast of North Viet Nam's chief port.
