again, after being forced to do battle for the peace and safety of its own capital city, not against foreign aggressors, but against Americans?

Our government had, for that troubled weekend, no fewer than 20,000 troops in readiness to act in Washington. Of these, no fewer than 2,000 were actually trucked to the underground entrance to the Pentagon itself during Friday night, and were housed there in the building during the weekend.

Another 2,000 contingent had been alerted to Andrews Air Force Base, where it bided down in tents along the runway, available for helicopter delivery in battalion size groups into the city if necessary.

Our government made these preparations because it had no certain way of knowing it could trust Americans not to turn our capital city into a bloody tragic mess as their violent, unjust way of trying to combine protest against a war with resentment against domestic injustice.

And not to leave the unrealistic impression of all the fault and irresponsibility lay merely with the irresponsibility — the very government which felt such diemal preparedness necessary was also, of course, the government which had been responsible for over-prosecution of the war abroad, under-benefits on the war at home.

The blame for whatever led up to such a weekend cannot be spread on any one way. The shame that came so close, and then, mercifully, never did fully materialize, would have been on all.

**A Glimpse Of Heresy**

You never know what excuse the heresy is going to employ to arise on what occasion.

One would have thought, for instance, that the attainment of our status as a nation of 200,000,000 people would have been a relatively safe occasion, reserved in a display of what also would be it to have 200,000,000 people all putting themselves on the back at the same precise moment.

One would have thought that very moment — heresy edged its outlandish way into the picture.

In it good to be just a great number here? In what respect are 200,000,000 people better than 2,000,000?

In there any reliable relationship between quantity and quality?

Are 200,000,000 happier?

All this implicit heresy, we are glad to report, lasted only for a brief moment.

A second or two later, it was 200,000,000, and we were off and on our way again to 300,000,000.

**The Shameful Might-Have-Been**

The dimensions of the preparations our national government at Washington felt prepared to make for the anti-war demonstration last month have gradually become public, and they must be shocking, in more ways than one, to all who love America, even though they may differ over American policy in Vietnam.

The first shock to that of the mere idea — obviously in the minds of some of the fringes of the anti-war movement — is the idea of our Defense Department strategists as well as some body would try to parlay the anti-war sentiment of the marchers to the Pentagon into a deliberate explosion of racial riot in the predominantly Negro city of Washington.

The second shock is also, fortunately, primarily mental. It is that of trying to conceive what we ourselves would have felt, what the rest of the world would have thought, if the worst had happened to cross the thin line that separated it from what did actually happen. What if our government had been called upon to display, in hot public use, those preparations which have now been disclosed in the cool aftermath? Could this nation ever have held its head high

**Crime 'Strike Forces'**

WASHINGTON (AP) — Special Federal Investigative "strike forces" now being formed will concentrate on serious areas of organized crime in the East and Midwest, Washington officials have indicated.

The "strike forces" will be made up of investigators from the Treasury Department's Internal Security and Audit Division, the Bureau of Narcotics, the Bureau of Customs, and the racketeering division of the Labor Department. The criminal division of the Justice Department will coordinate the investigative effort.

It was learned that the new operation's first concentrated efforts against organized crime will be in New York, Philadelphia, St. Louis and Chicago. New York City, particularly the area of Philadelphia and Ohio and southwestern Michigan; eastern Pennsylvania, especially the Lehigh Valley; Philadelphia to Southern New Jersey; southern Louisiana and Florida; and Kansas City and St. Louis as a single unit.

**Gas for Riots**

WASHINGTON (AP) — Non-toxic gas and riot firearms made up of stop violence outbreaks, three military experts have told the President's Advisory Commission on Civil Disorders.

The commission released Saturday testimony taken Sept. 20, from retired Maj. Gen. Roger L. Hill, California adjutant general from 1961 to 1966; Maj. Gen. George M. Gelston, Maryland adjutant general, and Brig. Gen. Harris W. Hollis, operations director of the Army Ordnance School, Fort Belvoir, Ill., for military operations.

Gelston and Hill advised against using tear gas and weapons in riotous situations. They agreed with Hollis who said, "We are taking stands now for limited objectives in the attempt to determine what we can do to stop violence, but we are not far away from a time when we may have to take a stand later in a greater conflict."

**A Difference in Sanctuaries**

There seems little doubt that either the Vietcong or North Vietnamese troops are using non-involved countries like Laos and Cambodia as staging areas for their operations. The Vietcong are fighting inside South Vietnam. Similarly, the United States is using Okinawa, Japan, Thailand as staging sanctuaries in its prosecution of staged war effort in Vietnam.

To continue with this kind of definition of "sanctuary," our enemy in Vietnam also obtains supply and possibly manpower from sanctuaries in Communist China and in Russia, and would undoubtedly use Chinese territory as sanctuary for guerrilla operations if we should ever cross the year that deeply into North Vietnam. And, in the same kind of definition, the whole of the United States is, of course, "sanctuary" for our own war effort in Vietnam.

By such definitions, "sanctuary" is a place from which you can supply, stage, or operate a war without being subject to attack in that place. "Sanctuary" is a place where you can be made while you hit somebody else.

The definition of "sanctuary" we have been outlining is not, obviously, enough, quite the definition that fits the way each side of a war feels about sanctuaries.

There is a further definition which is not really ours. A "sanctuary" is particularly annoying, particularly restricting, when the other side possesses the physical capacity to hit at its turn. Thus the United States, as a belligerent in Vietnam, has the physical capacity — the weaponry — to hit Laos, Cambodia, or Communist China. The fact that we have this power to hit such enemy sanctuaries increases our feeling of angry frustration over their existence. North Vietnam and the Vietcong, on the other hand, possess no physical power to hit us in Okinawa, or Japan, or in the United States itself. The only way they could ever attain the ability to hit us in our sanctuaries would be to bring their own big potential allies, Russia and China, into the war, with the weaponry that would match our own weaponry in its capacity to reach and blast any sanctuary anywhere in the world.

Then there would be no sanctuary for civilization itself.

Is there any great moral difference between one side of the war using Cambodia and the other using Okinawa? Is the one more unfair than the other?

Or is it merely our feeling that we can hit Cambodia, while North Vietnam can't possibly hit Okinawa, which fuels our own sense of righteous outrage? One suspects that, as in most things, feeling about sanctuaries depends on whose sanctuary seems vulnerable.

The developer's representative told that each apartment would have its own heating system. An engineer at the public meeting stated that within this 51.7 acre area there would be two tons of air pollutant issuing from these chimneys during a 24-hour period. Since the area under discussion is surrounded by little ground, there will be very little air to clean in this densely populated area.

### Quiet Place For Studying A Necessity

Architects and builders should plan homes with a new point of view. The moderate priced home available to today's average family is out of whack with our times and teen-age population.

These World War II era type dwellings make no provision for study or recreation. Something called a family room must suffice. It can't because it doesn't do the job. It is nothing more than a noise trap in most homes—someone watching television while someone else plays piano or tries to read a book.

Young people can't find a quiet place in their homes for study, one reason they room "to study at Millie's" or to "sleep over at Joanne's." Today's educational pressures are greater than ever but young people have less privacy for school work than their grandparents enjoyed.

Parents who moved into typical World War II houses as new-layers accept crowded family rooms as a problem of "a growing family." They can't afford to pay much more for a new house, but would have pretty much the same setup in one they could afford. The trend is to accept it until the youngsters go off to college or get married.

If one is strapped for funds to build an addition on a house, one should look around for other alternatives.

For example, does the family car need a better house than teenagers enjoy?

Put the car out and turn the garage into a recreation room, a place where young people can unleash their energies with basketball-hoop, ping-pong table, teenage parties, dances.

The family room could then be turned into a quiet study. If there isn't a family room, corral space from another area, like a large living room, sometimes merely throwing away junk in an attic and insulating it will provide the answer.

A mental library observed in one house recently had been a sewing room but was like an oasis after all the noisy family rooms that one encounters. The 8 by 10 room is walled by bookshelves to the ceiling. There were two small tables, two comfortable chairs, a large dictionary, a globe of the world, a telephone and a carpeted floor that increased the quiet feeling.

The teen-agers who use the room are top students. Their mother confided that she doesn't miss the sewing room. She moves her portable machine into the room when they are at school.

Another arrangement in such a room could be to have one large table along the wall where young people could spread out with their school books. Or individual tables could be pulled out of enclosed cabinets below bookshelves.

WASHINGTON (AP) — The Army is slashing war production orders involving millions of dollars and is shifting around other millions in on-hand goods in a broad effort to avoid wasteful surpluses in Vietnam, Pentagon sources report.

The move is in line with Secretary of Defense Robert S.

McNamara's new directive urging efforts to "avoid the inefficiencies and waste" of past wars.

McNamara told the services and defense agencies Friday the Korean war resulted in \$18 billion in supply excesses, much of which had little salvage value because of deterioration and obsolescence.

The Pentagon plans to use ships returning from Vietnam to haul excess supplies to Okinawa and other Pacific areas.

The Army's Logistics Command in Vietnam has reported its redistribution program may save an estimated \$200 million by next July.

Gen. William C. Westmoreland, U.S. Commander in Vietnam, said last week in a Washington speech he is intensifying "logical management" to deal with any surpluses.






