### Tollard PZC Agrees to Limit New Commercial Zone

Reversing a previous decision, the Planning and Zoning Commission last night agreed to limit a change of zone from Residential A to commercial in the northern corner of the Anthony Rd. intersection with Rt. 106.

In a decision two weeks ago, the PZC had agreed to extend the commercial zone from its present boundaries on Rt. 106 (Morrow Rd.) to Goose Lane and Rhodes Rd., through to the Coventry line.

After studying the proposal, the PZC decided no benefits could be derived by the town, for zoning the densely populated area between Anthony Rd. and Whitehall Hill Rd.

The zone change would have included a portion of the Tollard Summit area, including Summit Dr., and the area under the boundaries established last night, the PZC is fulfilling the request of a majority of the landowners involved as received in a petition submitted to the PZC in October of last year. The zone change would be effective for a 1,000-foot depth on each side of Rt. 106.

The petitioners had agreed to wait until the PZC had completed revision of the commercial zone regulations and adopted them.

The date of the public hearing is tentatively set for Sept. 29 at 8 p.m. in the Town Hall.

In other business the PZC made arrangements for the printing of the newly adopted commercial zone regulations, and discussed various proposals.

Scientists Tend To Snub Themselves With Dreams

STORRS, Conn. (AP) — Another Robert Goddard might well be snubbed by professional groups today the way the late rocket pioneer was snubbed in his day, says a University of Connecticut scientist.

The iron law of learned professional societies was, and still is, that they should deal only in proven realities... certainly not in fantasies, said Dean Arthur B. Bronwell.

In a paper for presentation at the Pan-American Congress of Engineering in Buenos Aires, Rio Rico, Bronwell cited the case of Goddard as a striking example of professional "blindness" to new ideas.

Goddard has been credited by rocket expert Werner von Braun with every major discovery in the field of rocketry except electronic guidance. Bronwell said.

Airline Won't Fight Over Florida Jetport Fears Hijack

WASHINGTON (AP) — The fight over a proposed jet airport near the Florida Everglades appears far from over, despite reports to the contrary.

Richard H. Judy, deputy director of the Dade County Port Authority, says his group has no intention of relocating the giant jetport which conservationists fear would destroy the swamp and wildlife of Everglades National Park.

"He has been in Cuba during the past eight years and we said we can't afford to run the risk of a hijacking," Williams was still in a cell in London's Old Bailey Prison. The 40-year-old Negro has reportedly gone on hunger strike to protest his detention.

Interest Rate On Taxes Is Up, Collector Notes

MANCHESTER (Herald Staff Writer) — Interest rates on taxes are up, according to a collector's notes.

Mrs. Cynthia Clark, tax collector, would like to remind the taxpayers about the increase in the interest rate which went into effect April 1. The rate is now three-fourths per cent per month, or nine per cent per year. This is an increase of three per cent per year.

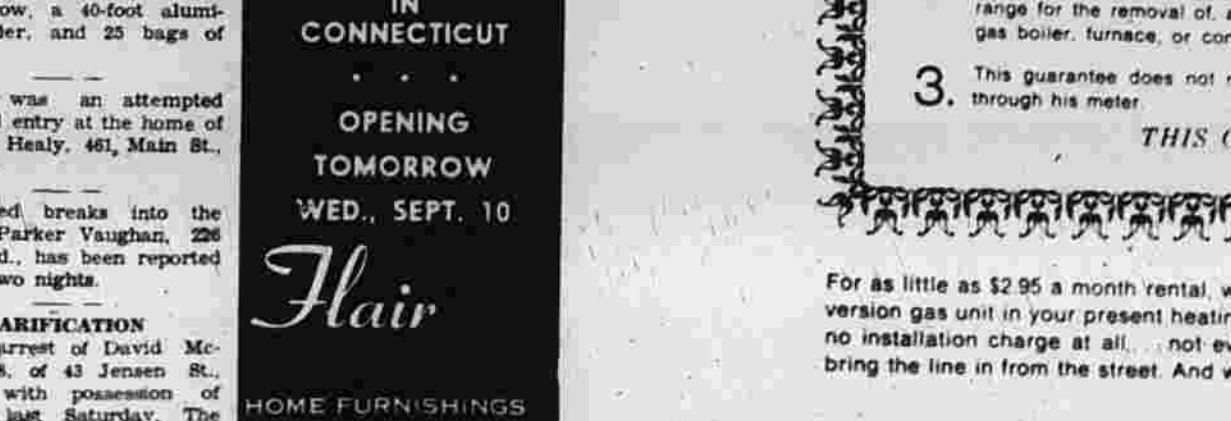
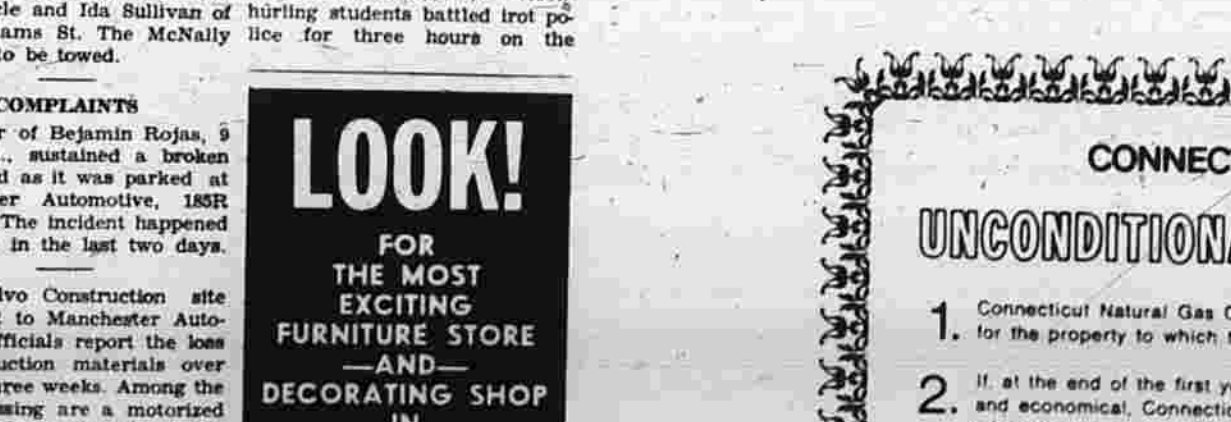
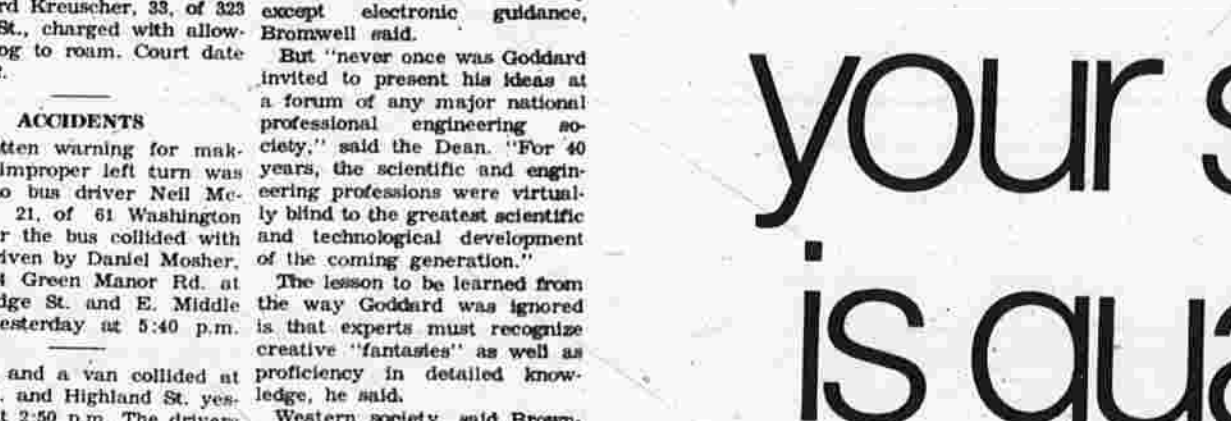
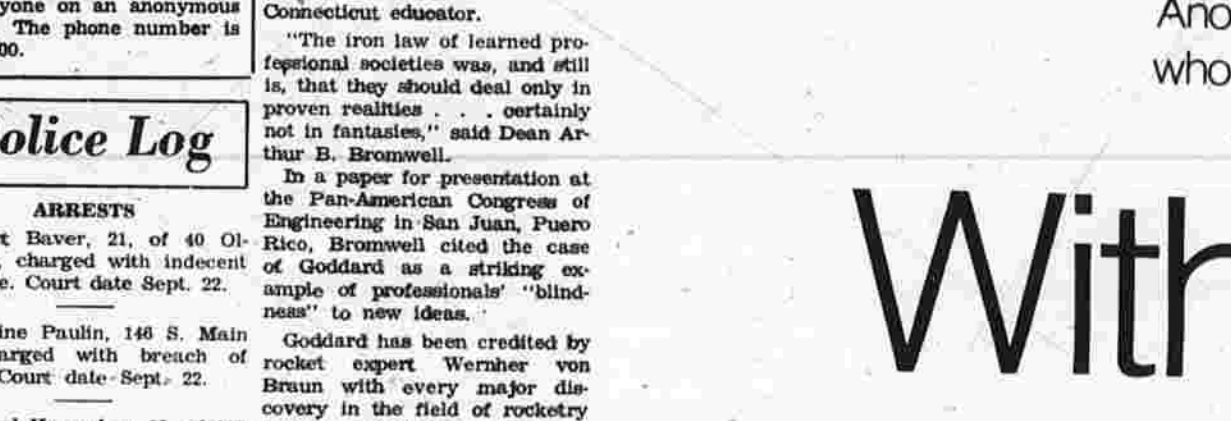
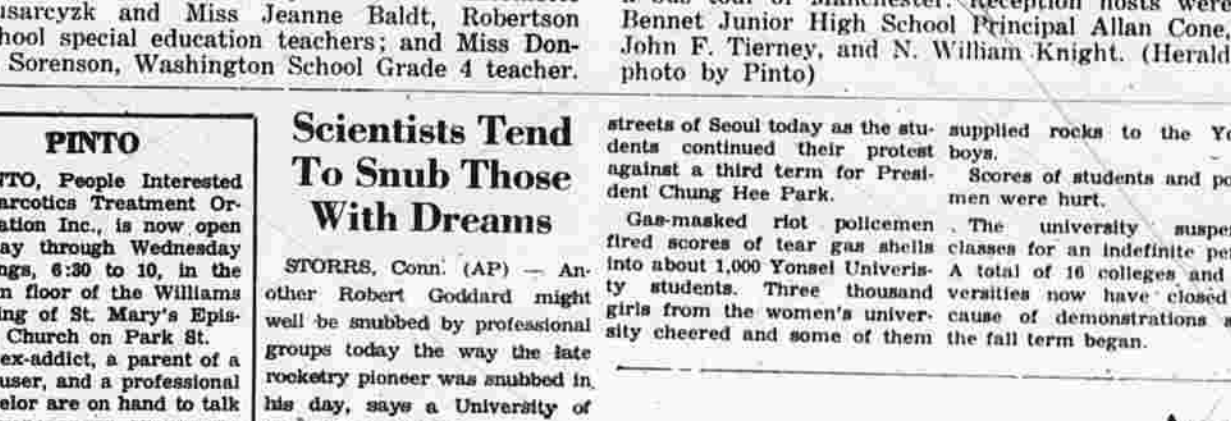
Once a tax payment becomes delinquent, the total tax immediately due in full. If not paid, it remains delinquent the entire year and interest on the amount of three-fourths per cent on the unpaid balance is charged.

Also a new tax law which becomes effective Oct. 1, 1969, states that any tax payment received shall be applied automatically by the collector to the oldest outstanding tax obligation of that taxpayer.

All tax information on motor vehicles comes from the Motor Vehicle Department and unless their records are kept up to date, tax bills will be received on cars sold or traded prior to Oct. 1, 1969. In order for the Motor Vehicle Department to correctly process the information, they must be notified of any change of address or change of ownership, and plates must be turned in unless transferred to another vehicle.

If registrations on all motor vehicles show exactly the same name and address, only one tax bill would be sent, but even a variance of one letter in a name or address brings more than one tax bill.

Anyone eligible for a veterans exemption must have his papers on file with the collector prior to Oct. 1, 1969. Office hours of the tax collector for the month of September are as follows: Monday (every week) 7:30 p.m.; Friday, 2-4 p.m. and Sept. 28th and 29th, 2-4 p.m.
