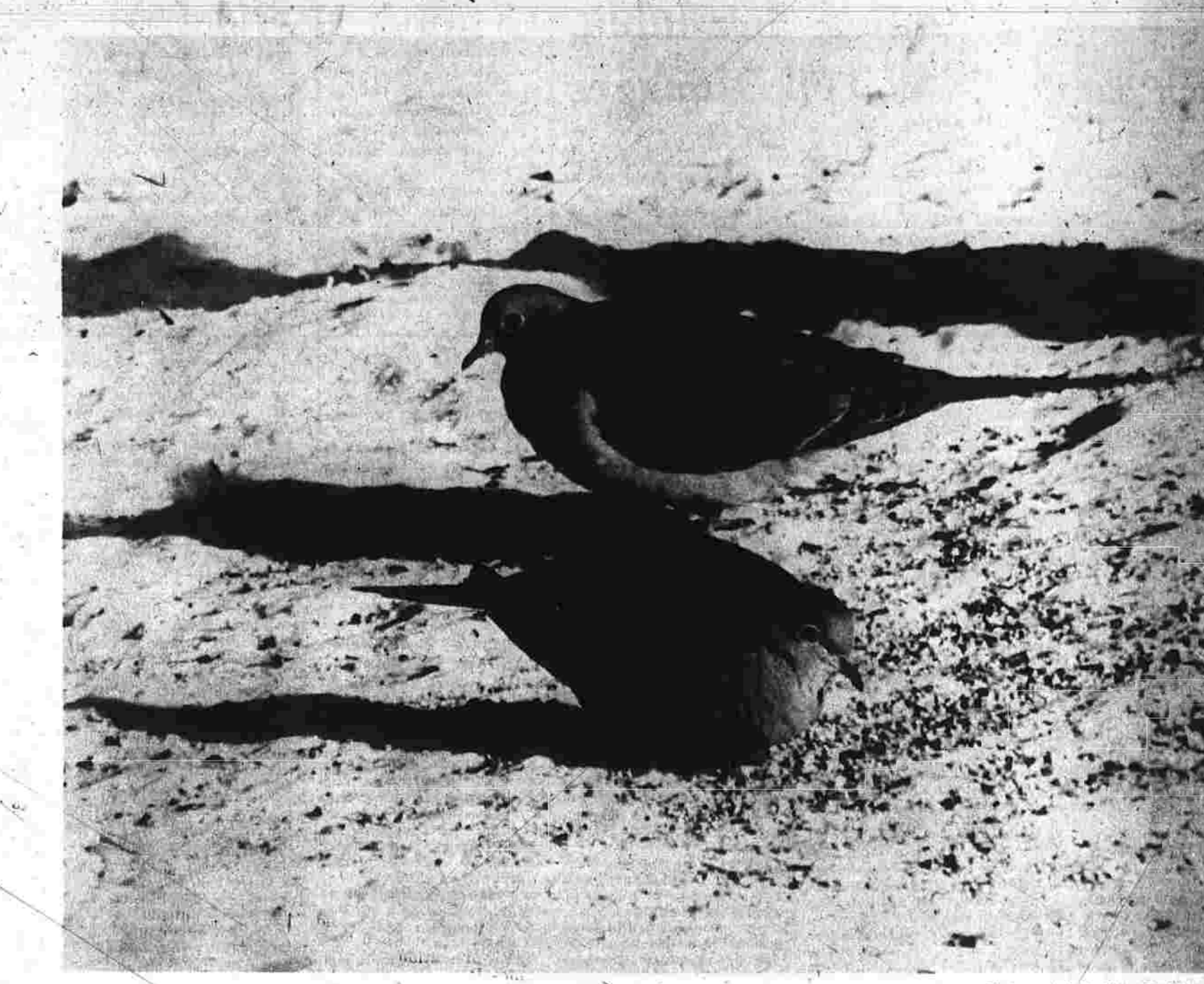

Inside Report Connecticut Yankee Askev Vs. Wallace

TALLAHASSEE, Fla. — The Democratic Presidential primary campaign here, a snafu of leathery, has now been transformed into a head-on battle between Gov. Reubin Askew, a church-going teetotaler with steel in his spine who would be very liberal with regard to P.O.W.'s are held by the enemy. After that we will consider it, but it is not a question of whether or not we should pay the price that anyone should pay for violating the law."

Presumably, the President means that he would consider reducing the penalty because individuals may now surrender to the government and receive a 50 percent cut to action.
