District turns down offer

Directors of the Eighth Utilities District have rejected the offer of a district firefighter to donate a large van to the district fire department for use as a dive team vehicle.

With one abstention, the district directors present at a meeting Thursday voted to follow the recommendation of District Fire Chief John Mace that the offer be turned down and the van be ordered removed from the parking lot of district headquarters at 18 Main St. In a letter to the directors, Mace said the van's

brakes need repair, the engine has problems and there may be problems with the steering and suspension system. Mace said in the letter that he sees no practical purpose for the vehicle.

The question was put on the agenda by Director Willard Marvin who then abstained the vote for Marvin said it would cost about \$1,000 to repair

the van for use by divers. Director Joseph Tripp, fire commissioner, said it would cost from \$10,000 to \$20,000 to put a diving team into service. He said in the past 10 years there has been only one call for a diving team, involving

New elders van approved

The town's Board of Directors have approved the purchase of an additional van for a program that provides free transportation for elderly residents of Manchester and Bolton.

The town is contributing \$2,850 to help pay for the 14-passenger van. Most of the \$33,000 for the vehicle will come from the state and the remainder from some private contributors.

The program is coordinated by the Elderly Outreach Division of the town Human Services Depart-

Coordinator of Elderly Outreach Diane Wicks said the program allows older people - who may not drive or have access to transportation - to do such things as see their doctors, go grocery shop-ping, and visit relatives in nursing homes. Wicks explained that the additional van is needed

because the existing van is often used by other agencies to perform similar functions. Also, she said the 12-passenger van is not large enough to always support the amount of people that

want service, so second trips have to be made. Another reason the van is needed is because the existing van is not properly equipped for wheelchairs, but the new one, expected to be purchased in the fall, will be.





8th District postpones ordinance

Owners of businesses located with the Eighth Utilities District will get an opportunity to study and comment on a proposed ordinance that will affect them before that ordinance goes to district voters for consideration.

The ordinance, if passed, would require employers of more than 10 people to permit district volunteer firefighters to leave their jobs during daytime hours to fight structure fires or serious hazardous materials inci-

The ordinance would prohibit the employers from deducting from a worker's pay or benefits because the worker responded to an emergency. Some directors said they were concerned that employers might consider the terms of the ordinance arbitrary and that good relations between employers and the fire department might be damaged.

The district directors had planned to seek a district vote on the ordinance at a special meeting June 18, but at a meeting Thursday the directors voted to get the views of business owners first and postpone a districtwide vote until after July 15 when a new board of directors takes

In the interim, the district will mail copies of the proposed ordinance and copies of the state law that authorizes such ordinances to district business owners with a request that they offer their opinions on its provisions.

The ordinance was one of several items the directors had considered putting to vote June 18. As a result of decisions Thursday, however, only one will be.

The district voters will be asked to reappropriate a sum of up to \$17,000 to buy protective gear for firefighters. The funds would come from unanticipated surplus in the current budget.

Also postponed was consideration of an agreement to allow the town to take a triangle of land needed in front of the district fire station on Tolland Turnpike for widening the



Tax-dodging millionaire sentenced

BRIDGEPORT - Peter M Brant, a millionaire businessman, socialite and polo player, lived a ifestyle of the rich and famous, but was sentenced to three months in iederal prison for using company credit cards to pay for his ex-

ravagance. Brant, who once hosted the Duke and Duchess of York, was sentenced Thursday for violating federal tax laws by putting his household servants on his company payroll and charging jewelry, clothing and antiques for his family on company redit cards.

In addition to the three-month prison term, U.S. District Judge T.F. Gilroy Daly fined Brant \$200,000 d gave him five years probab during which he must perform at least 500 hours of community ser-

Brant, 43, pleaded guilty in April to misdemeanor charges of willful failure to maintain records and con-

"I accept the responsibility for the mess that occurred," Brant told Daly, who imposed a sentence of one year in prison suspended after 90 days.

"I'd just like to say that this has been a very difficult five-year period for me," Brant said. "It's been devastating for me and my family, and it certainly will make me a person who will be more tolerant in the future of judging others."

Brant rushed from the courtroom with his wife Sandy after the sentencing and would not talk with reporters. He must surrender July 16 to begin serving his sentence. The judge said he will recommend that Brant serve his time at the minimum-security federal prison camp at Allenwood, Pa.

Federal prosecutors alleged that Brant and members of his family charged more than \$1.5 million in personal expenses to his newsprint. companies from 1981 to 1984.

As part of a plea agreement, Brant had already agreed to pay \$250,000 in taxes owed the federal govern-ment and a \$125,000 civil fraud

Brant's cousin and business partner, Joseph Allen of New York, and their two newsprint companies, The Bato Co. Inc. and its subsidiary, Riviere du Loup Newsprint Ltd., also pleaded guilty to tax charges. Daly fined each company a total of \$1 million, the maximum.

In their sentencing memorandum prosecutors depicted an extravagant lifestyle financed by company credit cards. Some of the purchases made by the Brant and Allen families included designer clothing, silk sheets and linens, fine art, oriental rugs, fine china, scalp treatments, body massages, services at day camps and health clubs, and vacations.

Brant, who owns a 1,500-acre estate and is an avid horseman, is a top-rated polo player and established the Greenwich Polo Club Inc. in 1983. In 1987, he played host there to Prince Andrew and Sarah Ferguson, the Duke and Duchess of York, in their first trip to America after their wedding. Brant and his wife also have other

business intcrests, including Brant Publications, which publishes Antiques, Art In America, Interview and The Thoroughbred Record.

Brant's attorney, H. James Pickerstein, asked the judge to spare Brant a prison term, citing his extensive charitable work. The only specific examples he mentioned were Brant's sponsoring charity polo matches at the Greenwich club and helping out with medical bills

businesses, universities and government agencies are teaming up to develop an advanced computer network that would transmit data 700 times faster than currently possible, The New York Times reported

The project is expected to be announced later today by the National Science Foundation, based in Washington, D.C.

The high-speed computer network would enable the transmission of 1 billion bits of computer data per second via fiber-optic cables currently used for telephone service.

Government laboratories at Los Alamos, N.M., and Livermore, Calif., will participate in what would be the first comprehensive effort in the United States to advance the technologically critical area of computer networks, the newspaper said. Dozens of corporations, including IBM, AT&T, MCI, and the regional Bell companies, and such universities as the Massachusetts Institute of Technology, the University of Pennsylvania, the California Institute of Technology and the University of California at Berkeley, will participate, it said.

The network might be used to link computers and televisions to allow users to manipulate images on screen and transmit them to other users within seconds.

Another use would be threedimensional medical imaging that would allow doctors thousands of miles away to simultaneously analyze lifelike images.



The 1 1/2-mile Belmont Stakes, the final and most challenging leg of horse racing's coveted Triple Crown, is usually a highly anticipated event. Either a horse enters the Belmont, after sweeping the

Kentucky Derby and Preakness with a chance to win the elusive Triple Crown, or a rubber match between the Derby and Preakness winners exists, thus providing a certain drama. The former scenario existed a year ago when Sunday

Silence had an opportunity to become the first Triple Crown winner since Affirmed in 1978. Easy Goer, second to Sunday Silence in the Derby and Preakness, foiled his plans by romping to an eight-length victory in the Belmont.

This year, Derby winner Unbridled will run the Belmont, Preakness winner Summer Squall, however, will not. Squall's handlers were concerned with his full racing schedule this spring and the fact that Lasix, a diuretic drug prescribed to control respiratory bleeding in

racehorses, is banned in New York. Summer Squall had used Lasix in the Derby and Preakness, as did Unbridled. Mr. Frisky, who won his initial 16 career starts before finishing eighth in the Derby and third in the Preakness, won't run the Belmont due to

recently been diagnosed with papillary thyroid cancer. Can you provide facts on cause, procedures and prog-

DEAR READER: Papillary carcinoma is the most common thyroid malignancy, constituting about 65 percent of all thyroid cancers. The cause is unknown, but it is frequently associated with a history of radiation exposure (such as X-ray treatments that were popular years ago for acne therapy). The tumor often affects young people (under 40 years) and is more common in women. The cancer appears to be less malignant in younger patients than in the elderly.

Treatment consists of surgical removal of the malignancy, followed by thyroid suppression, meaning synthetic thyroid hormone is used to deactivate the thyroid gland, thereby suppressing any natural production of thyroid hormone. This combined therapy is almost always effective. With modern treatment, your husband has a favorable prognosis

DEAR DR. GOTT: Can you tell me what apnea is, and what causes it? My 57-year-old son has been diagnosed with it. Is this inherited? DEAR READER: Apnea, the absence of breathing, is

a symptom, not a disease. In adults, apnea is usually associated with death or near-death, such as drowning, choking on a foreign object or massive injury. If patients with apnea are to survive, they must be given assisted ventilation - either with mouth-to-mouth resuscitation or with a breathing device. Apnea lasting more than thee minutes causes permanent and severe brain damage be-

The concept of life care (or continuing care) retirement ommunities is not new. The first were established early in this century. The greatest growth has come in the last 30 years and about 50 new ones open each year. There are more than 700 life care communities nationwide, serving 230,000 residents. According to a 1989 study by the accounting firm Ernst & Young for the American Association of Homes for the Aging (AAHA), three-fourths of the communities have waiting lists and more than half are planning to expand.

Traditionally the sponsors of continuing care retirement communities have been religious or other nonprofit organizations, and they continue to dominate. Frequently the project is financed with tax-exempt bonds. The entry of profit-making corporations, particularly hotel chains in recent years, disturbs leaders of the nonprofits, says Deborah Cloud of AAHA, and some favor

restricting commercial ventures. The Internal Revenue Service last month threatened action in cases where charitable organizations and private operators buy or sell properties financed with tax-exempt bonds. Yet, continued growth of commercially sponsored

communities seems inevitable. Laventhol & Horwath says as many as 280,000 new units could be needed by 1993. Because of the aging population, the demand will be in the millions by the turn of the century. Already a major force in the market, Marriott Corpora-

tion plans to develop 150 "independent full-service and catered living" communities over the next five years at a cost of well over \$1 billion. Unlike many existing facilities that are sold as condominiums, all the Marriott units will be rental. While church-related organizations in the health care

field are generally recognized for providing more compassionate care, it is reasonable that corporations with the experience and financial resources of Marriott will be able to provide a level of service difficult to surpass. Motivated as they are, some nonprofit communities still suffer from poor financial planning and management. Life care communities have three features in common: there is an entry fee, a monthly fee, and residents have

access to health care, usually a nursing ward on the" premises. There are three types of contracts: All-inclusive con-

tracts include nursing home care at no extra cost. Modified contracts include nursing home care, but for a limited period. Under a fee-for-service contract, residents pay extra for nursing home care. the entry fee ranges from around \$20,000 to \$100,000, depending on the type of contract and the size of the living unit. Monthly fees average from \$600 to \$1,000. You may be surprised to learn that these fees make life care living an option for half the population over 65 years old, drawing on the equity in their home, pension plan and Social Security. Committing yourself to a contract with a life care community is a major decision and should not be made without the assistance of an able lawyer or financial adviser. in addition, AAHA suggests you: · Spend time at the facility determining if life style is

compatible with yours. Talk to the residents, the health care coordinator and the manager, if permitted, live there for a weekend.

· Compare prices at several facilities in your area. Go over the contract carefully, paying close attention to extras and refunds. What happens if you are unable to pay the monthly charges?


