State's Economy Challenged

By DON MEIKLE Associated Press Writer HARTFORD (AP)—Calls for economic strengthening by the leader of the Republican minority in the Connecticut House of Representatives filed three bills Tuesday calling for tax cuts and added spending.

The bills were introduced by Rep. Francis J. Collins of Brookfield, who has been a vocal critic of the state's economic situation.

In a speech Tuesday at the annual meeting of the Connecticut Council of Economic Advisors, Collins called for economy in state government. But he tied bills the same day which would boost state grants to local school systems, provide additional tax relief for elderly homeowners, and cut the state sales tax on manufacturers' equipment.

The Collins bill to raise the state's average daily membership (ADM) grants to local school systems from \$200 per pupil per year to \$220 was cosponsored by Rep. J. Brian Gaffney of New Britain, a close associate of Gov. Thomas Meskill.

Presumably, the Collins bill represents the Meskill administration's willingness to go along with a 10 per cent increase in state spending. However, the increase in the public school population will mean a total dollar increase of more than 10 per cent.

The increase in students is just one of many built-in factors which make it very difficult to hold the line on state expenditures.

Collins' stern demand for state agencies to come back with budgets no more than 10 per cent higher than those of the present fiscal year is the GOP right hand of economy.

Collins' bills represent the more generous left hand of the GOP.

The strategy remains to be worked out during the legislative session which begins on Jan. 6, and it remains to be seen whether the GOP can pose on the one hand as the champion of budgeted taxpayers and on the other hand as the builder of highways, schools, hospitals and other things which various citizens are clamoring for.

In his speech Tuesday, Collins appeared to foreshadow a more liberal Republican image than Meskill has indicated.

Collins figured the "bare bones" minimum increase in the state budget at \$70 million. That's considerably more than the \$37 million needed to make up the \$30 million deficit and boost current expenditures by 10 per cent.

And Collins did not take clear stand against a state income tax. He merely figured it would take a "piggy-back" state tax of 12 to 18 per cent of the federal income tax paid by Connecticut residents to cover the \$70 million budget boost he had predicted. And he said it would be unfair simply to grant such a tax onto the present "hurry-bully" tax structure.

Collins did not indicate whether he would oppose a state income tax if it were accompanied by a thorough restructuring of the tax system.

White House Still Shy Of Wage Ceiling

By BILL MEHRER WASHINGTON (AP)—Despite a tough, more specific inflation alert, the White House still is staying away from using direct presidential influence where it counts—on pending wage and price increases.

In issuing its second alert Tuesday, President Nixon's Council of Economic Advisors limited criticism mostly to past wage and price decisions, indicating it isn't ready to go further.

The council said the focus for combating inflation will be on the government's monetary and fiscal policies and appeals to aid "increased understanding and voluntary cooperation."

One change in local policy came Tuesday when the maximum interest rate on FHA—and mortgage—rates was reduced from 8 1/2 to 8 per cent.

The higher ceiling had been in effect since Jan. 5. The reduction was hailed as a significant step toward curbing the home building industry.

The inflation alert criticized gasoline and car price rises and wage increases in the automobile, airline and construction industries. It said a proposed wage settlement in the railroad industry might contribute to inflation.

The after-the-fact tone of the report raised doubts in many quarters that the administration's tactics will work.

"The inflation alert is analogous to Paul Revere riding again and shouting, 'The British have been here,'" said Robert Johnson, research director of the New York brokerage firm of Faine, Webber, Jackson & Currie.

"At least it's an expression of public interest in wages and prices," Johnson said. "It's not enough to be effective," said R. Thomas Saunders, economist for the Chemical Bank of New York.

The alert did signal a slight administration move into "jawboning," the use of presidential influence on wage and price increases.

The council said the government now will aim "more decisively at expansion" and cautioned that its policy would be hampered by a race between management and labor for high profits and pay.

"If everyone in his turn gets as big a wage or price increase as the biggest obtained by others during the height of the inflation, the inflation will go on endlessly," the alert said.

President George Meany lambasted the alert as "heavily weighted against wage increases for workers, but a very solicited about profits and business—especially those profit margins increased this year and 'some further rise is to be expected'."

He said the alert's attack on the wage settlement between General Motors and the United Auto Workers was unwarranted.

"It is clear that this settlement," the report said, "if generalized throughout the economy, would crowd further upward costs per unit of output and, therefore, the price level."

About the time the report was released, Chrysler announced a \$10 average increase in its suggested retail price for 1971 models. It was the company's second price increase this year. Chrysler mentioned in the alert.

The council's comment on a presidentially proposed wage settlement for the railroad industry, averaging 9 per cent over the cost of cost-of-living adjustments, was milder than expected. The criticism was limited to the board's recommendation that pay boosts were designed to cover an assumed 6 per cent increase in the cost of living.

The alert criticized General Motors for boosting the price of 1971 automobiles by between 6 and 7 per cent, saying it would add "about \$2 billion to the total cost to dealers and possibly \$2.5 billion to the cost of consumers."

Sheinwold on Bridge

LISTEN TO BRIDGING TO AVOID HAD LEAD By ALBERT SHEINWOLD

"The opening lead is blind," said Albert Sheinwold, the great English expert, "for deal players." If you listen carefully to the bidding you should be able to build a picture of the unseen hands; and that picture should guide you in a good opening lead—or, at least, away from a bad lead. Today's hand tells a story of a man who simply wouldn't listen.

West led the jack of spades, announcing what he fondly imagined to be a bright suit. "It's a suit is good enough to bid, it's good enough to lead." This is just about as sensible as a rolling stone gathers a stick in time.

Declarer tried a finesse with dummy's queen of spades since he was ready to ruff if East unexpectedly showed up with the king. But East produced a queen and jack and not two spade tricks to get rid of his diamonds at all.

South then drew trumps and gave up one heart and one club, making his game with an over-trick.

Simple Message The bidding told a simple message. If West had only listened to the North bid and rebid trump in the teeth of West's spade bid, it was reasonable to assume that dummy would show up with the A-Q of spades.

South showed great length in hearts and clubs, and a reluctance to settle for a no-trump contract. What could be more likely than a drastic shortness in spades?

In short, West should have foreseen that dummy would provide two spade tricks and that South might get two immediate "discards" with a spade opening lead.

West couldn't be sure that a diamond lead would defeat the contract, but he should have known that a spade lead would be hopeless. The queen of diamonds would at least give a defense a chance.

Yule Bonus Helps Benumb Thoughts of a Recession

By JOHN GUNNIF NEW YORK (AP)—Notes on how ordinary Americans make, spend and often lose their money.

Year-end and Christmas bonuses this December may not be the plums they were in more prosperous years, but they still appear sweet enough to make some employees forget about a recession.

Eastman Kodak will distribute \$90 million to 67,000 U.S. employees, more than \$9 million more than a year ago. The amount per person is based on a payment of \$134 for each \$1,000 earned during 1969-1970.

A study of 147 companies by Fry Consultants Inc. shows that 77.5 per cent plan no change in the size of their year-end payments. Of the remainder, 4.5 per cent will have a higher and 18.2 per cent a lower payout.

Many securities bankers who customarily celebrate the holidays with bonuses equal to several months' salary are not practicing this year. Just to have a job is hard enough in some instances.

The New York Stock Exchange, however, is maintaining the practice, although the size of its bonuses will be about 7.5 per cent of salary, compared with about 10 per cent last year.

Factors such as lower total income could play some role in a renewed deterioration of consumer confidence. After having proved in late summer, the Conference Board says, confidence has again fallen back.

More Records and Tapes

NEW YORK (AP)—More than \$1.7 billion worth of photographic records and pre-recorded tapes will be sold at retail in 1970, according to preliminary estimates, the Recording Industry Association of America says.

This forecast is an increase of 9 per cent over volume of 1969, \$1,658 billion.

Preliminary estimates indicate that record sales in 1970 will total \$1.2 billion, of which \$1,008 billion will come from the retail of long-playing records, 1969, total record sales amounted to \$1,170 billion, of which \$995 million was from sales of LP records.

Sales of prerecorded tapes will amount to \$833 million, according to the estimates, of which \$400 million from sales of eight-track cartridges, \$108 million from cassette, \$20 million from reel-to-reel tapes and \$8 million from four-track cartridges and playtapes, \$21 million.

Pre-recorded tape sales in 1969 were valued at \$416 million, eight-track cartridges, \$200 million; cassettes, \$75 million; reel-to-reel, \$20 million, and four-track cartridges and playtapes, \$21 million.

Two Russian Revolutionists

Two Russians are currently in the news, the one for not wanting to go back to his own country, the other for fearing he might not be allowed to go back to his own country.

In both instances, the attitude and reasoning of the Russian involved constitutes an indictment of his own country. In one instance, a question is raised about American conduct in Vietnam.

One of the Russians is the Lithuanian seaman known as Simas. While a Russian fishing trawler and a Coast Guard vessel were hashed together during negotiations over fishing problems.

Simas made tentative arrangements with American personnel on the Coast Guard boat to desert his own vessel and seek political asylum in this country.

By his tentative planning, he was supposed to slip overboard after the two vessels had separated, and then be rescued by the Americans.

Instead, he jumped from one deck to the other while the two vessels were still tied together.

In such unexpected circumstances, and with the Russian captain claiming that Simas had committed a \$2,000 theft en route to freedom, our authorities finally gave the Russians permission to come over and take their man back.

The news story which followed, based on accounts from witnesses, gave a chilling account of the Russian crewmen being held up by the Coast Guard.

The second Russian in the news is Aleksandr Solzhenitsyn, the Russian novelist who recently was awarded the 1970 Nobel Prize for Literature.

This, by proper standards for a national passenger service, should not be an option, but a possibility, but a guaranteed certainty, like some of the routes definitely slated in the Volpe prospectus, for abandonment.

There ought to be a regular, vastly improved railroad passenger service to and between all major points, if government and government dollars are going to be involved, the beginning plan should not be allowed to provide anything less than that.

Wise Step? Washington's temptation to bomb enemy installations in North Vietnam was obviously strong. We only hope that the justification for this action will turn out to be equally strong.

If an unarmed observer plane was shot down by the North Vietnamese, this would seem to call for some kind of a warning against repetition.

Town May Be Site For Retardate School

A regional occupational training center for the mentally retarded, to cost between \$500,000 and \$650,000 and to be fully funded by the state, may be constructed in Manchester by 1975, if the Board of Directors and the electors approve.

The facility, explained the proposal to the directors last night, would be a new building; or a furnishing, occupational, training and mental retardation center, possibly could free some of the school rooms now used for that purpose.

The construction would be under the provisions of Public Act 10-788, which requires the state's towns and cities to educate and train all exceptionally handicapped children between ages 4 and 21.

The town's obligation for the center would be to provide a site of approximately five acres, to construct the facility, and to operate it on a regional basis for at least five years.

The state would reimburse the town the entire construction cost upon completion. At the end of five years, the state would be made obligated to a regional facility, the center would be sold to the town for use as a regional or locally sufficient for retraining plan town officials decide on.

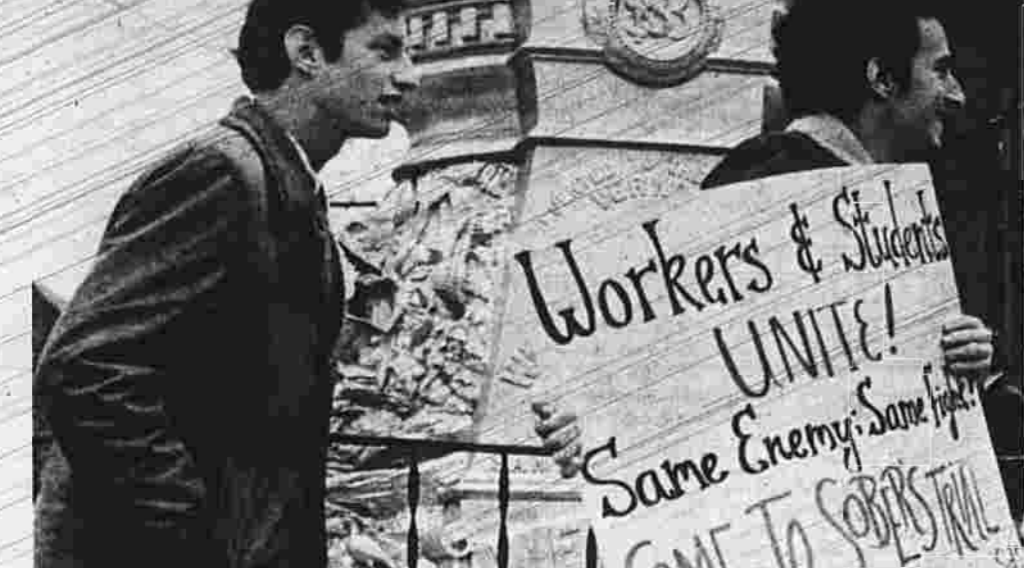

Although CPEEC predicts heavier financial burdens for the towns experiencing the heaviest percentage of newcomers, the theory does not hold particularly true for Tolland and Hebron. The percentage of property tax increases in the two towns, although high is considerably lower than in other area towns in their population categories.

Tolland's increase last year was less than Coventry's, and Ellington's, while Hebron's was lower than neighboring Andover and Columbia.

This situation runs contrary to common thought, and is perhaps best explained by the corresponding growth in the grand total of the two towns, compensating in part for the increased expenditures.

The other towns have been faced with mounting budgets attributable to higher teacher salaries and increasing costs in other areas, without the benefits of an increasing tax base.

In both Tolland and Hebron the lion's share of the budget goes for education and may for new school construction.

Both communities have the lowest per pupil costs however, of any of the area towns according to statistics provided by the CPEEC in another report.

Neither town has sewers, although with increasing development they are becoming an acknowledged need in Tolland, and First Selectman Charles Thiffault is mulling over details of a proposal for a five year utilities study for the town concentrating on sewers and refuse disposal.

Highways No Freedom

Highway construction has not become a problem, since developers have attracted the newcomers by building houses along existing town roads or have constructed their own roads to town specifications.

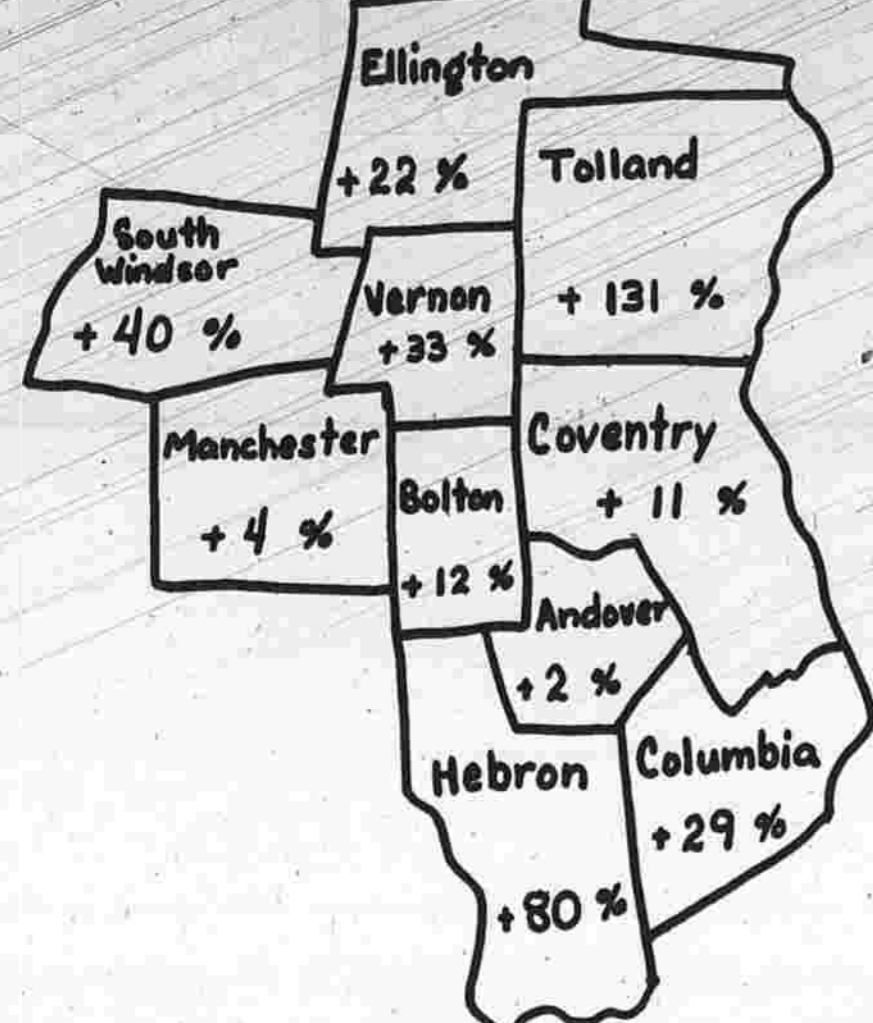
Concentrations of groups at subdivisions are beginning to strain several older town roads in Tolland, however.

Also affected by the subdivision concentrations, may be the basic educational policy of Tolland, which concentrates all the local schools in the center of town as part of an educational policy. This policy, dictated by the previous scattered development of the town.

School construction problems can stay around a long time for a town, as evidenced by Vernon and South Windsor's present considerations for additional high school space. Both of these towns experienced great influxes of people during the 1960-60 decade. The children of these families are now reaching high school age and space must be found for them.

The demand for increased municipal services is rearing its head in the growth towns, as more and more people who formerly lived in more urban areas move out to the country and are surprised at the municipal services they previously took for granted.

Among the most critical of these services is refuse. Although most of the area towns do not provide municipal refuse pickup, the problems and expenses of maintaining town

dumping under increasingly stringent down into the difference between 1960 and 1970 census statistics, and takes into account births and deaths to arrive at the migratory figure.

Although on a percentage factually hard hit, as they find the valuable space in their area, it actually had the largest influx of people with 6,681 new residents.

Hebron's population was 1,819 in 1960 increasing to 3,796 in 1970. The town recorded 651 births compared to 166 deaths, leaving a migratory increase of 1,484 residents.

Manchester's 1960 population was 42,102 increasing to 47,840 in 1970. The town recorded 8,254 births, which were offset by 4,028 deaths, leaving a new resident increase of 1,862 people.

South Windsor's 1960 population was 9,460 compared to 15,650 in 1970. The town recorded 3,991 births, which were offset by 812 deaths, resulting in a migratory figure of 3,811 new residents.

Tolland's 1960 population was 2,360, jumping to 7,644 in 1970.

Workman's Plight, The Other 4 Days

By J. HUNTER HOLLOWAY

LITTLETON, Colo. (AP) — Paul Patterson's Jeep is parked outside, ready for three days of "snow-busting" in the high Rockies overlooking the fashionable Denver suburb. Lori Coffelt is looking forward to three days with her children.

Executive George Gregory has a golf date Friday and plans to finish pushing his basement grounds and begin a three-day weekend.

Rest of the weekend? Right. Come 4 p.m. every Thursday Paul, Lori, George and 450 other employees of C. A. Norgren Co., walk out of their modern plant, drive through the landscaped grounds and begin a three-day weekend.

Norgren's employees put in 37 hours a week at work. But it's a spread over four work days, not a standard 40-hour week.

A United Steelworkers union survey shows Norgren is one of at least 27 companies—employing a total of some 1,800 people—that now have a four-day work week in one form or another.

The four-day week, a dream of most every working man and woman, is just one of many innovations adopted by Norgren, a manufacturer of air processing systems which profits sharing came 25 years ago. Pleasant working conditions and music piped through the sky lunchroom are other novelties. So's the landscaped and around the sprawling two-story brick and stone building. The manicured lawns spreading several hundred yards across the front of the plant and around its large, landscaped pond attracted a pair of Canada geese six years ago. Now more than two dozen cavort on the grass.

The \$10-million a year family owned company instituted the four-day work week on Aug. 31. It meant going from a traditional day's work on a Monday through Thursday, and then a five-day week to 37 hours, and amounted to an hourly salary increase of 7 1/2 per cent.

The company says applications for employment jumped 300 per cent the week after the announcement, and have held at that level since.

"It's kind of early to tell just what economic effect it's having on us," said George Gregory, head of Norgren's advertising and marketing. "We got the general feeling we will be able to maintain or increase our production."

The greatest majority of the employees like it, he said, although "there were a few grumbles about the long hours."

The plant runs two shifts, the day shift from 7 a.m. to 3 p.m. and 7 a.m. to 4 p.m. on Thursday. That's 37 hours, with a half hour for lunch. The night shift comes on at 5 p.m. and works through 3 a.m., except on Thursdays when the shift ends at 2 a.m.

With a degree of pride, Gregory said unions had attempted to establish themselves at Norgren twice in the past. "They weren't successful," he said.

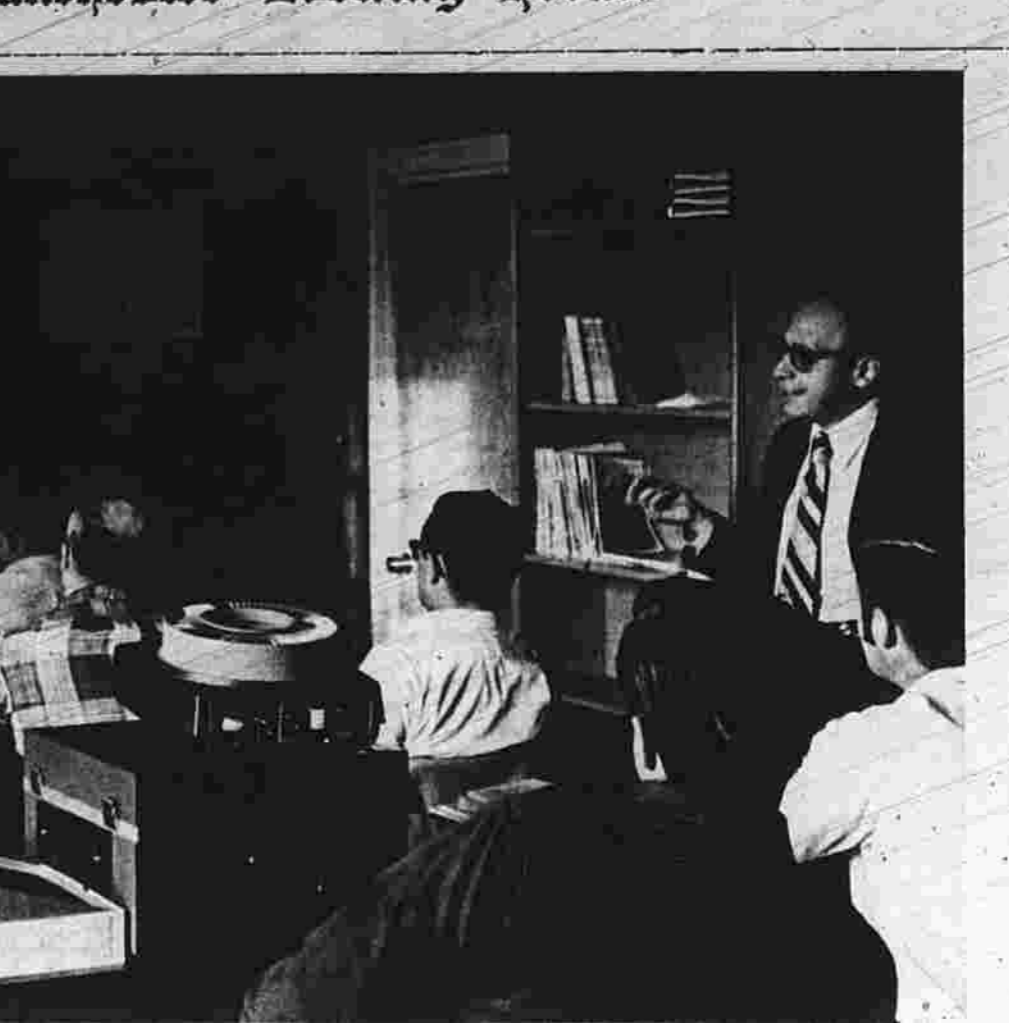

'Living It Up' On Anniversary Of Heart Switch

ALPENA, Mich. (AP)—Donald Lee Kaminski, 40-year-old cigarette smoker, beer drinker, outdoorsman and life of the party, today celebrates the second anniversary of his heart transplant.

"You know, people have a little heart trouble and they sit around, so careful and that's that's not my way," Kaminski said in an interview.

Kaminski was close to death when he received the heart transplant at the University of Michigan Hospital in Ann Arbor on Dec. 2, 1968.

"He was going to die. He was just here to see whether we could think of anything else to help him. But he was terminal," a doctor at the university's medical center said.

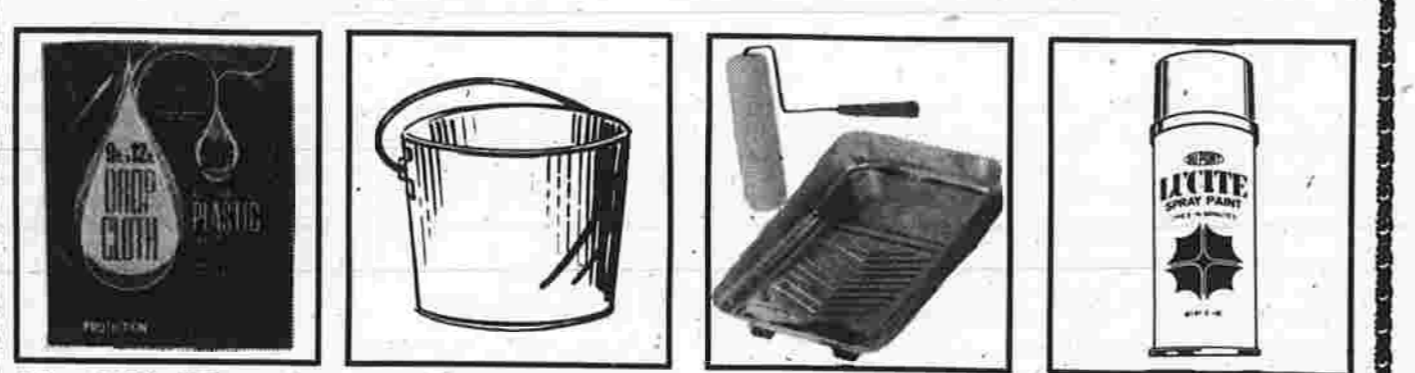

Unique in both scope and potential, EPA is mandated to establish and enforce anti-pollution standards, administer financial grants, and help conduct research and help develop a national environmental policy.

That makes it the supreme federal pollution-fighter, and all the more so because it assembles under one roof existing anti-pollution programs, formerly scattered among the Interior Department, Department of Health, Education and Welfare, Department of Agriculture, and Atomic Energy Commission.

The second corner is the Council on Environmental Quality, a three-member panel of advisers to the President.

Even as EPA became a legal reality, William D. Ruckelshaus, director of the Justice Department's civil law division, was still testifying before the Senate, which has yet to confirm his nomination as director of EPA.

Agency Nominee Vows He'll Fume Till Autos Don't

WASHINGTON (AP) — Asst. Atty. Gen. William Ruckelshaus, nominated to head the new Environmental Protection Agency, has promised maximum pressure on the auto industry to eliminate 90 per cent of harmful exhaust fumes within four years.

Ruckelshaus, testifying during Senate Public Works Committee consideration of his nomination, promised to "view with the most jaundiced eye" any claim that the auto industry could not produce an adequate emission control device by 1975.

"I would hold the auto industry to the strictest," he said Tuesday.

Sen. Edmund S. Muskie, D-Maine, suggested to Ruckelshaus that a recent letter from Elliot L. Richardson, secretary of health, education and welfare, indicated the Nixon administration might be so insistent with car manufacturers.

In a letter to Senate-House conferees considering an anti-pollution bill which includes the Jan. 1, 1975, deadline, Richardson said the administration is not satisfied with the way a one-year escape clause for the industry would operate.

Richardson suggested extensions be placed under the agency Ruckelshaus would head, perhaps with an independent body such as the National Academy of Sciences acting as adviser and with the entire decision reviewable by the courts.

Ruckelshaus told the committee the Richardson procedure would be the most orderly and dispassionate method of dealing with the problem.

But Muskie countered that the auto industry would be given a perfect out should the science academy rule that industry did not have the technology to eliminate 90 per cent of harmful fumes—and did not determine whether efforts had been made to develop that technology.

"You know," Muskie said, "it's just conceivable that by 1975 we will know enough more about the health impact of automobile emissions to decide that whether or not the technology exists, dirty cars ought not to be made any more."

Vote Switch Places SST In Doubt

WASHINGTON (AP) — A Republican senator usually lined up behind Nixon administration policies has split from GOP ranks to oppose continued aid to the supersonic transport.

Sen. Jack Miller, R-Iowa, thereby put in doubt the fate of a \$200 million appropriation bill for further SST development.

Miller said the real needs of the future are not in carrying out the program until we have much stronger evidence of the positive advantages and much stronger evidence to negate the possible disadvantages," Miller said.

Attempts to muffle the huge plane's engine have not been proven feasible, Miller declared, and he said it's clear the aircraft would cause excessive airport noise.

He also said the SST money could be put to better use in a number of other areas.

Toronto Judge Ousts Charges Against Attorney

TORONTO (AP) — Assault charges against Chicago attorney William Kunzler were dismissed by a Toronto judge Tuesday.

Kunzler, the defense attorney for Paul Fromm, was accused of slugging a witness in the head with a water pitcher, knocking him unconscious during a speaking engagement June 22 at the University of Toronto.

Judge J. Tupper Bigelow dismissed the charges of common assault and assault with intent to do bodily harm on the grounds that neither could be proved beyond reasonable doubt.

Washington has a special affection for the old shade tree growing on the boundary line of his property.

But Jenks, the man next door, considered it an eyesore. One day Jenks announced he was going to cut away half of the tree, trunk and all.

Watson hastened into court for a stop order. But at the hearing, Jenks stood firm.

"I own everything up to the boundary line," he said, "including half of the tree. If his half cannot survive on its own, that is his problem—not mine."

Nevertheless, the court ordered Jenks to leave the tree alone. The judge said the tree was owned not in two separate halves but jointly, with neither owner permitted to destroy the property rights of the other.

This is the law's usual attitude toward natural growth that happens to be located on a boundary line. Based on simple practicality, the rule generally applies not only to trees but to hedges as well.

Still, the rule has certain circumstances. Take this situation: A boundary line hedge between two homes began to get top-heavy. One of the home owners rented an electric shear and cut the hedge down low. His neighbor promptly filed suit for damages, accusing him of cutting away part of their jointly-owned property without permission.

But the court, unable to discern any damage, turned down the neighbor's claim. The court pointed out that the hedge, trimmed down, was actually in better condition than it had been before.

Occasionally even a total destruction by one of the co-owners may be justified. In another case, the roots of an apple tree split the foundation of one of the adjacent houses. Overhead, the branches had grown dangerously brittle. Lopping off the roots and branches, according to a tree expert, could well cause the whole tree to topple over.

This line, a court ruled that the tree could be destroyed altogether. The court said the victim of a nuisance has the right to abate it—and this tree could fairly be classified as a nuisance.

Coast Guard At Fault In Stray Buoy

NEW YORK (AP) — The U.S. Coast Guard, for letting a buoy stray, must bear the blame and the costs for a 1969 super-tanker accident that dumped crude oil along 60 miles of the Maine coast.

Government lawyers wanted the tanker's operators to share liability, alleging failure to use "good navigation" as the Northern Gulf approached Casco Bay and Portland Nov. 28, 1969.

The three judges faulted the Coast Guard for leaving the buoy displaced, possibly for about eight months, when a fixed Coast Guard station could have detected it and a buoy tender promptly and several cutters based at Portland, passed the buoy frequently.

The government failed to convince federal district Judge Charles H. Tenney that the Italian officers and Portland Harbor pilot should have cross checked their position as they rounded the buoy with 281,429 barrels of crude oil for a Portsmouth-Montreal pipeline.

Last May, both sides in the litigation agreed on a tentative formula to be used if the higher court affirmed Judge Tenney. It would mean \$55,844 for the tanker's owners, Afran Transport Co., and \$124,536.56 for the owners of the oil, British-American Oil Co. Ltd., of Canada—plus interest.

No Postage Due BRUSH, Colo. (AP) — A penny postage stamp issued recently with the notation: "No postage due. It was mailed in New York 29 years ago."

Chuck Gale said the card was received by his father, Charles Gale Sr., 83, although it was addressed to the younger Gale's mother, who died a year after it was mailed.

Included with the card was a note from the post office saying that while dismantling a post office in Ohio, the card was found and sent on its way with no postage due. Post card postage has gone up 800 per cent since 1941.

November Rain Below Average

Precipitation in Manchester last month was just below average, with 3.50 inches measured and 3.88 inches anticipated, according to Stanley Lambert, assistant superintendent of the Town Water Department.

Lambert reported that precipitation for the 11 months since Jan. 1 was 6.64 inches below average—32.35 inches recorded and 39.19 inches anticipated.

He said that the town's four storage reservoirs measure a little less than 900 million gallons, against a capacity of 479 million gallons. He said that the drop in the storage level poses no problem for the town, since water is being drawn from all of the town's wells.
